  - o Coles County was the first Master Gardener program in "rural" Illinois.
  - This year, the program is celebrating the 50th anniversary of the Master Gardener Program
  - 32 Master Gardeners in our program (based on 2024 annual report)
  - The program holds fundraisers (annual plant sale, Spring into Gardening), charges program fees when applicable and applies for grants to help offset the cost of the program.

#### **Old Business**

- Board membership
  - Discussed reducing our max membership number on the council to nine people, versus the current minimum of 15. New guidelines are being finalized by Illinois Extension Leadership.
  - Discussed how many people from each county (for equal representation) should be the mandate.
  - Board members encouraged Jessie Streit to reach out to Board Chairs and educate them on the importance of their appointees to attend Council meetings. Use it as an opportunity to educate.

### **New Business**

- SNAP-Ed Program
  - USDA gave approval to use funding through 2/14/26; funding/programming was initially supposed to end in October 2025.
  - SNAP-Ed is not LINK cards. SNAP-Ed provides nutrition education, food access and safety training, etc., SNAP-Ed has nothing to do with the administration of SNAP benefits.
  - Most popular in the unit has been the Partners in Produce and Hunters Feeding Illinois programs. Additionally, school and community programming such as IL. Junior Chef and Health Cents.
    - The board expressed that they hoped programs like those above would continue in some way moving forward.
  - Tom Webb asked what money the five-county area needs to keep our counties afloat within these programs.
    - The current SNAP-Ed budget is approximately \$480K, but does not include funds to purchase food for Partners in Produce and benefits.
  - Spending restrictions are occurring throughout the SNAP-Ed program

  - Jessie Streit provided a report of all programming from October 1, 2024, through August 31, 2025.
  - Discussed 4-H membership numbers
    - Shelby County is tied for 4th place with Champaign County.

  - Coles County 4-H Program Coordinator
  - Temp Office Support staff member in the Arthur office
  - Partnering with a neighboring unit (Edgar, Clark, and Edgar counties) to hire a Nutrition and Wellness Educator.
