Fiscal Reports

- House Bill 2264 was discussed, explaining how the Illinois Department of Ag is a passthrough for Extension money and that the State of Illinois lobbied to change the wording of the law was changed from "may pay" to "shall pay." This was done to alleviate the confusion in wording, preventing the Illinois Department of Ag from keeping more of Extension's funds. On August 16, the bill was passed into law.
- FY19 Report We received two state payments in FY19. One was in December for FY18. The second was received in May, which was a payout from campus, using Smith Lever funds to help support local units during the state budget crisis. Once the state receives those matching funds, the Smith Lever funds will be paid back to campus.
- FY20 Budget -
 - County board funding:
 - Livingston will stay at the same levy amount
 - Woodford finance committee met today because several board members were new and had a lot of questions about Extension. Bobbie and all of the educators attended to provide them with local programming information and updates.
 - McLean's levy was decreased for one year for FY21. This decision was made due to carryover the unit had from the previous fiscal year.
- Extension has been doing fiscal audits on units, and we were chosen to have ours done in July for FY19, reviewing all three counties. Several of the Extension Business staff reviewed items such as PCards, travel, Purchase Orders, fiscal processes and much more. They asked questions of staff about spending and processes used within the unit. Few audit findings were discovered. They requested to use some of our local processes state-wide and complimented the staff on being fiscally responsible.

Business Items

Staffing Update

- The Local Food Systems & Small Farms Educator resigned his position. Ryan Hobson, the Regional Director for our unit, is putting together a search committee to get this position refilled.
- We have hired a part-time Office Support Assistant to work in all three counties. RaeJean Kuntz will start on September 16 but will leave a vacant position on council after her start date. Please officially welcome RaeJean Kuntz!
- Meg Meeker was hired as the McLean 4-H Program Coordinator. She started working the same week as the McLean County Fair.

Civil Rights Compliance

- Our last Civil Rights Audit was in 2017, and our staff always does a great job promoting programs to diverse audiences.
 - Professional development is offered to staff to keep them up-to-date.
 - During a recent staff meeting, Life Center for Independent Living (CIL) came to present a program to staff about disabilities and services that can be provided to accommodate their needs.
 - In April, all staff will go through a 3-day training called Navigating Differences, on cultural competencies.
