The University of Illinois Extension Councils and Extension Boards are subject to the Illinois Open Meetings Act (OMA). OMA rules state that all members of a public body (including *ex officio* members) must complete the OMA electronic training.

- ✓ Training must be completed no later than the 90th day after assuming responsibilities as a member of the public body.
- Elected or appointed members of a public body subject to OMA must complete the electronic training once during their term of election or appointment.
- ✓ Elected or appointed members need <u>not</u> complete the electronic training on an annual basis thereafter.

You must create an account in order to record your training completion.
