Treasurer Books & Secretary Books – due August 31

At the end of the 4-H year on August 31, all 4-H clubs are required to turn in their Treasurer Book (unless they do not have a treasury) and Secretary Book to the Extension Office. If you are a Secretary or Treasurer, please be sure you are keeping your records and turn in your completed book to your club leader by August 31. If you are a club leader, please check with your officers to be sure they are on track. Illinois State Fair General Project Exhibit Information

The very best projects exhibited at the 2021 Sangamon/Menard General Projects Show have been chosen to exhibit alongside 4-H'ers from across the state at the 2021 Illinois State Fair. Exhibits chosen from Sangamon and Menard counties will show on **Saturday, August 14**. The 4-H member must be present to exhibit. If he or she cannot be present, the opportunity is given to an alternate. General Project exhibits must be **in place by 9:00 AM and remain on display until 3:30 PM**. Judging times will be posted at check-in and are not related to the order in which you check-in. All projects are displayed in the Orr Building, which is air-conditioned.

The awards will include Champion Medals for the highest score in each project class and Reserve Medals for the second highest score in each class. Cash premiums from the state will be paid to the medal winners. Innovation Awards will be given to exhibits judges find inspiring, innovative, or creative and are not based on scores.

Illinois State Fair Livestock Entry Information

Illinois State Fair Junior Department classes, requirements, and entry forms are available at https://www2.illinois.gov/statefair/competitions/premium-books. State Fair Junior Livestock Department entries must be submitted by the 4-H member TO THE STATE FAIR. The deadline to enter the Illinois State Fair Junior Livestock Shows is July 15. Entries must have a membership verification signature from the Extension Office before you submit them to the State Fair entry department. Deadline for this verification is July 14 (regardless of date printed on the State's form). You may want to call in advance of stopping by the Extension Office to make sure a staff person who can verify your enrollment is present.

Show What Makes Your Club Great at the Illinois State Fair

Illinois 4-H is seeking clubs to host an activity or demonstration in the Orr Building during the 4-H State Fair exhibit days. Final table picks and a schedule will be determined by July 12, and Illinois 4-H will provide a \$250 stipend. Two clubs for each day and time slot will be selected. Tech Prairie STEAM Expo at Illinois State Fair

The Illinois Department of Innovation & Technology (DoIT) will debut the Tech Prairie STEAM Expo at this year's Illinois State Fair. The event will provide fairgoers with opportunities to experience the many ways Illinois is advancing the areas of STEAM (Science, Technology, Engineering, Arts and Mathematics). Feature attractions planned include a mobile CNC lab, flight simulator, virtual reality opportunities, health sciences stations, aerospace exhibits, and the Hip Hop Xpress Bus. The Expo will be held **August 18-22** in the Orr Building.

As part of Tech Prairie, the first State Fair drone competition is scheduled for Friday, August 20, in the Multi-Purpose Arena on the Illinois State Fairgrounds. Pilots, age 10 and up, are welcome to compete and there is no fee to enter. The Central Illinois Drone Racers are managing the event and prizes will be awarded to winners. An Esports competition is planned for Saturday, August 21, in the Tech Prairie STEAM Expo. Four separate games will be part of the in-person competition with prize money awarded in each age category and game. There is no fee to enter. The Esports competition is organized by the University of Illinois Extension 4-H.

State 4-H Poultry Judging Contest

The State 4-H Poultry Judging Contest will be held Monday, **August 16**, 4:30-6:30 PM in the Junior Livestock Building at the Illinois State Fairgrounds. Registration will take place that day at 4:00 PM. A county team may be made up of three or four contestants with no limit on the number of teams or individuals. The scores of the three highest scoring individuals from each team will be totaled to determine each team score. All contestants will be eligible for all individual honors. The four highest senior 4-H'ers (age 14-18 as of January 1) will be selected to participate on the state team. The highest scoring individuals will be invited to participate in the National 4-H Poultry and Egg Conference the third week of November in Louisville, KY. 
4-H in Space – Mission Command Team

How to Disagree & Still Be Friends

Navigating the challenges of disagreement is a part of the 4-H experience. Judges may disagree with members on the completeness of work presented at fair. Disagreements may be present within clubs. Disagreement doesn't elude the 4-H experience. For some individuals, disagreements can be a very uncomfortable experience. It may bring up feelings of nervousness, anxiety, and an overall feeling of being ill at ease. Many individuals do all they can to avoid engaging in disagreements. They censor their comments or affirm decisions they know are wrong simply to eliminate the possibility of engaging in a disagreement. But knowing that disagreement happens, and there are times it simply cannot be avoided, how can we make our disagreements civil and respectful? How can we use disagreements to truly make our best even better?

Here are 5 tips for managing disagreements and using them to create learning opportunities:

Assume good

When you disagree with a person, be cautious about assigning a negative intention to what that person has said or done. Interacting with the assumption of good intentions creates a positive outlook to disagreement. Assuming good intentions keeps the focus on a collaborative learning environment that benefits 4-H members, their families, volunteers, and 4-H staff. This allows you to focus on the content of the disagreement, and not the person or the relationship. What is the disagreement about? Answering that and keeping it at the center keeps learning at the forefront. The content in question can be discussed without things becoming personal. When it becomes personal, learning about content cannot take place. Assuming persons are acting from places of good intentions eliminates the temptation to make it about the person, and not about the disagreement regarding content or behavior.

Listen

While listening is a basic requirement in communication, fully listening during disagreements can easily not be seen as a priority. Often the priority becomes to get a point across and win an argument. In these cases, individuals are simply waiting to respond and not fully listening. Take the "edge of the seat" test. If you feel as though you are on the "edge of your seat" eager to respond, it is likely you are not fully listening. If you are relaxed and sitting with your back touching the back of your chair, you are likely fully listening.

Use "I" statements

Leading with "you do" this or that, invites defensiveness. When individuals are engaged in defensiveness, their focus is not on the content of the disagreement or being able to fully listen. Using "you" can feel like a personal attack, and not a simple disagreement. Utilizing "I" statements keeps the disagreement conversational. It eliminates the argumentative tone, something that is often at the source of ill feelings regarding disagreement. Saying, "I feel" and then describing the situation as you see it invites an engaged response. Learning can occur and the focus can remain on the content of the disagreement.

Ask questions

During a disagreement, if you are not certain about intentions or meaning within the communication, ask clarifying questions. Asking questions from a perspective of learning as opposed to evaluating is key to keeping the conversation going. Examples include: Will you help me understand? Can you say more about that?

Practice

Using the above strategies may not be skills you frequently use. As with any skill, you must practice them in order to increase your proficiency. One way to do that is to allow for disagreement within your club meetings and model these skills for the 4-H members. This creates a common language and approach to disagreement that you can rely on in future situations.
