# 2021 Winnebago County 4-H Auction

## Clerk's Information for Buyers

First, thank you for attending this year's auction and we hope you find an opportunity to enjoy the satisfaction of supporting these young people as they participate in the positive activities that 4-H offers.

Here is some information that should make your auction experience pleasant and ensure that the disposition of the animals that you purchase will be handled efficiently. (**PLEASE NOTE:** The following information does not apply to *Fur & Feather* purchases. You are responsible for disposition of those purchases.)

1. After you purchase an animal, a runner will bring you the sales slip on a clipboard. PLEASE HOLD YOUR BUYER SIGN UP HIGH UNTIL YOU HAVE MADE EYE CONTACT WITH THE RUNNER. Please sign the sales slip and mark which shipper will be taking your animals. There are two methods of disposition. You can either send animals to one of the listed butchers or to one of the listed "resale" buyers, which are live markets. Please note: if you select "Other", you will need to make arrangements with your own trucker or with the exhibitor of the animal to have it sent to your chosen destination. Also, if you are not sure which animals you will want sent to slaughter and which to live market please make your best guess and mark the slip. If you come to the cashier's table at the end of the sale, we will be glad to make the changes you need.

Following this procedure should eliminate your having to track down a shipper at the end of the sale, as well as any confusion as to which animals go where.

2. If the exhibitor reserves the right to show at another fair, it will be the exhibitor's responsibility to arrange for delivery of the animal(s) you purchase to the place you designate on the sales ticket.
3. If you plan to send animals that sell as a pair to two different locations, please mark a second sales slip with the lot number of the animal and the second location. The runner will have blank sales slips for this purpose.
4. If you wish to "roll" the animal as a donation, the *4-H & Extension Foundation* **AND ONLY** the *4-H & Extension Foundation* must be the recipient of the donation. If you wish to contribute something to another cause, please work directly with that cause yourself. For example, you might have the animal slaughtered then donate the meat to your favorite organization, or sell the animal on the live market and donate the cash proceeds to them.
5. **PAYMENT IS EXPECTED BEFORE YOU LEAVE THE BUILDING** unless you have made previous arrangements with the clerk of the sale. It is unacceptable to delay payment until you have received the proceeds of your live market re-sale.
