Auction:

- Only Beef and Sheep may be purchased and sent to a locker or may be bought and resold at a slaughterhouse.
- For Swine, Goats, & Rabbit animals, if a buyer does not want the animal, then the 4-H member must retain ownership of the animal.
- ◆ Transportation to Eickmans will be provided <u>only</u> for beef, sheep, and swine who are not retaining ownership.
- ◆ A floor price will be set according to the current market trends the day of the auction. A list of current market prices will be available.
- Pork, lamb, & goat carcasses will be sold whole. Beef carcasses will be sold in halves.
- ♦ Some 4-H exhibitors will retain ownership of their show animals to show at other fairs throughout the summer. When this happens in 2022, buyers will only pay the difference between their bid and market price. To illustrate, if market price is \$.60 per pound and you bid \$.80 per pound, the difference would be \$.20 per pound. You would pay \$.20 per pound and leave the auction without further business to transact.
- ◆ For a list of 4-H'ers who are eligible to sell at the 2022 auction, please contact the Ogle County Extension Office at 815-732-2191 after June 30.
- The sale will be held in conjunction with the Ogle County Fair in the Beef Arena. Gate Admission will be required for new buyers. In appreciation to last year's buyers, they will receive a complimentary 1 day admission to the fair.
- ◆ In appreciation of all the 2022 buyers' support, the Auction Committee is providing 2 complimentary tickets to the Ogle County Pork Producers barbecue scheduled for August 6th from 5—7 p.m. Tickets will be distributed upon paid receipt.
