- Collaborate with team members to ensure successful execution of digital education deliverables.
- Work with internal and external creative staff, such as videographers, graphic designers, and web developers pertaining to digital education and production of instructional materials.

- To perform the functions of this position, the employee will be required to perform work both within an office and outside in the communities that are served, and must have the capability to travel from one location to the other in a timely fashion. Employee is responsible for securing personal transportation. A valid driver's license is preferred. Some work will be required during evenings and/or weekends. When working, the employee may be exposed to a variety of environmental factors to include, but not limited to, hot or cold weather, exposure to noise and allergens, and uneven ground. In performing the functions of this position, the employee may be subjected to various mental and physical demands as well to include, but not limited to, independently traveling to and performing work at different locations, lifting and moving items that may occasionally weigh up to forty (40) pounds and frequently weigh up to twenty (20) pounds, and twisting, pushing and pulling movements. Qualifications

Required:

- Master's Degree in nutrition, dietetics, public health, family and consumer sciences, or a related field. Candidates with a master's degree in progress may be considered for interviews, but degree must be completed by hire date.
- Experience with developing nutrition education materials.
- Experience with digital education technology platforms and digital editing software.
- At least 2 years of relevant experience. Experience working with diverse populations in a community setting.

Preferred:
