Species	Information
Beef Cattle	<ul style="list-style-type: none"> <li>• Ownership Dates:               <ul style="list-style-type: none"> <li>○ Steers must be owned by January 1</li> <li>○ All other cattle must be owned by May 1</li> </ul> </li> <li>• Tattooing:               <ul style="list-style-type: none"> <li>○ All steers or market heifers must be tattooed at the Clay County Beef Weight on February 3<sup>rd</sup>.</li> </ul> </li> <li>• YQCA is required yearly.</li> <li>• You may show 2 per class in the breeding division but will only be allowed to show a total of 2 steers.</li> <li>• Superintendent- Hank Hilmes &amp; Mark Pierson</li> </ul>
Cats	<ul style="list-style-type: none"> <li>• Heath certificate and proof of vaccinations signed by your veterinarian is required at check-in</li> <li>• Exhibitors must have completed QAEC at least once in their 4-H career.</li> </ul>
Dairy Cattle	<ul style="list-style-type: none"> <li>• Ownership Dates:               <ul style="list-style-type: none"> <li>○ Steers must be owned by January 1</li> <li>○ All other Cattle must be owned by May 1</li> </ul> </li> <li>• Tattooing:               <ul style="list-style-type: none"> <li>○ Steers must be tattooed at the Clay County Beef Weigh-in on February 3<sup>rd</sup>.</li> </ul> </li> <li>• YQCA is required yearly.</li> <li>• Superintendent- Hank Hilmes</li> </ul>
Dogs	<ul style="list-style-type: none"> <li>• You may only exhibit 1 dog per class and are allowed a maximum of 2 dogs for the show.</li> <li>• Exhibitors must have completed QAEC at least once in their 4-H career.</li> <li>• Must be owned or leased by May 1 of the current year.</li> <li>• Must have proof of vaccination records and health certificate.</li> </ul>
Goats	<ul style="list-style-type: none"> <li>• Ownership Deadline:               <ul style="list-style-type: none"> <li>○ May 1</li> </ul> </li> <li>• Meat Goats must be born on or after Oct. 1, 2023</li> <li>• All market goats must fill out and turn in their ownership forms by May 1.</li> <li>• All goats must have a form of identification- Tattoo or Tag</li> <li>• YQCA is required yearly.</li> <li>• Superintendent: Mandy &amp; Brad Clark</li> </ul>
Horse	<ul style="list-style-type: none"> <li>• Ownership Dates:               <ul style="list-style-type: none"> <li>○ Animal must be owned or leased by the exhibitor and the animal must be on file with the extension office by May 1 of the current year.</li> </ul> </li> <li>• Exhibitor must complete QAEC at least once in their 4-H career.</li> <li>• Coggins test is required day of show.</li> <li>• Superintendent- Ben Allen &amp; Bristol Burroughs</li> </ul>

<p style="text-align: center;"><b>Poultry</b></p>	<ul style="list-style-type: none"> <li>• All poultry must be owned by the exhibitor by June 15 of the current year.</li> <li>• Exhibitors must have completed QAEC at least once in their 4-H career.</li> <li>• Superintendent- Rocky Allen</li> </ul>
<p style="text-align: center;"><b>Rabbit</b></p>	<ul style="list-style-type: none"> <li>• All Rabbits must be owned by the exhibitor by June 15 of the current year.</li> <li>• Exhibitors must complete QAEC at least once in their 4-H career.</li> <li>• Superintendent- Rocky Allen</li> </ul>
<p style="text-align: center;"><b>Sheep</b></p>	<ul style="list-style-type: none"> <li>• All sheep must be owned by the exhibitor by May 1 of the current year.</li> <li>• Market Lambs must fill out the ownership form and submit this to the office by May 1.</li> <li>• All lambs must have scrapie's tags.</li> <li>• YQCA is required yearly.</li> <li>• Superintendent-</li> </ul>
<p style="text-align: center;"><b>Swine</b></p>	<ul style="list-style-type: none"> <li>• Ownership/Birthdate Requirements: <ul style="list-style-type: none"> <li>○ Barrows- <ul style="list-style-type: none"> <li>▪ Farrowed on or after January 1, 2024</li> <li>▪ Must be on the property of the exhibitor by May 1, 2024</li> </ul> </li> <li>○ Gilts- <ul style="list-style-type: none"> <li>▪ Farrowed on or after January 1, 2024</li> <li>▪ Owned by exhibitor since May 1, 2024</li> </ul> </li> </ul> </li> <li>• All swine are required to be tagged by May 1 with our county tags.</li> <li>• You must fill out a ownership form and submit it along with 3 pictures to the extension office by May 1 deadline.</li> <li>• YQCA is required yearly.</li> <li>• Superintendent- Keith &amp; Robyn Payne</li> </ul>
