We have exciting news to share about the public speaking contest this year! The five counties have gotten together, and we will be providing a unit-wide public speaking contest. The event will be on February 17 at 6 in the evening in the basement of the Edwards County Farm Bureau office.

How judging will happen is everyone will speak in front of two judges, and we will have an overall placement of 1-5 with awards. Then each county will have the opportunity to promote speakers from their counties to the state competition in April. If you have questions, please contact your local Extension office.

Important changes to livestock are being made this year for exhibition at the state and county levels. All beef, dairy, and swine will be required to have a USDA official animal identification number ear tag ("840" tag). The tag must be both visually and electronically capable of reading. Thus, means at check-ins at fair staff/superintendents will be checking tags with an electronic reader.

## Some common questions:

## Who must have the 840 Tag?

Beef- All Heifers, All Cows, All Steers being exhibited at fair Dairy- All Heifers, All Cows, All Steers being exhibited at fair

Swine- All Gilts, All Barrows being exhibited at fair

## Where do I get the 840 Tag?

Breeder you purchase your animal from

Local Veterinarian

Purchase Tag from a farm supply (Valley Vet, Nasco)

## How do I purchase my own tags?

The location of where the animal is being kept will have to have a registered premise ID with the state of Illinois. With the premise ID you will be able to purchase tags from a farm supply store such as Valley Vet or Nasco to name a few.

## I do not have a Premise ID how do I get one?

Obtain an application for the Illinois Department of Agriculture and send it in. The turn around time is very fast to get one. Search for a fillable premise form.
