### YQCA CERTIFICATION

4-H members exhibiting **Beef Cattle**, **Swine**, **Dairy Cattle**, **Goats**, **or Sheep** are required to complete the **Youth for the Quality Care of Animals** certification (YQCA). This statewide certification must be completed <u>each year</u>. **Youth MUST complete this training prior to the Saline County 4-H livestock shows.** This does not apply to youth exhibiting animal or veterinary science poster projects.

Visit: https://www.yqcaprogram.org/. Detailed instructions have been sent to all exhibitors.

We have an instructor-led training scheduled for Saturday, April 5th, at 11 am at the Saline County Fairgrounds prior to the Swine Weigh-in. The training will take approximately 1 hour. You must register online for the class, pay the \$3 fee, and take the pre-test BEFORE arriving on April 5.

Thank You to the Saline County Stockmen's Association for providing lunch at noon between the YQCA training and the Swine Weigh-in. They will also reimburse the \$3 fee after you complete the training.

You can also register and take the online course at your convenience. Cost for that option is \$12.

The deadline for the YQCA Certification is June 1.

Additional instructor-led YQCA sessions are planned for April 18 in Hamilton County & May 10 in White County.

#### QAEC

Exhibitors of Cat, Dog, Horse, Poultry, and/or Rabbits are required to take the **Quality Assurance** and Ethics Certification (QAEC) training. QAEC training is only required once in the member's career and is offered free of charge.

To take the training, families will log into Zsuite, choose the profile of the youth needing to test, select Clover Academy find the course and click Enroll. A new window will open with the course. Youth complete the introduction and then select the animal they plan to exhibit. When finished, go back to the youth's profile and it will indicate 100% complete. Youth must print certificate and bring to the Extension office.

Detailed instructions have been sent to all exhibitors who need to take this training.

The deadline for the QAEC certification is June 1.

#### **Livestock Committee News**

The Saline County Livestock Committee met on March 10th at 7:00 p.m. at the Extension office.

Members present finalized and approved the livestock pages in the handbook, discussed judges for the summer livestock shows, and approved the July Show calendar.

# Swine Weigh-In



The Saline County 4-H Swine Weigh-In will be held on Saturday, **April 5** at **1:00 pm** at the Fairgrounds. 4-H members enrolled in Market Swine projects who want to participate in the Swine Rate of Gain Contest should plan to attend.

The required 840 tag must be in the animal's ear before the weigh-in.

Market Swine projects not weighed for Rate of Gain must be tagged with an 840 tag and reported to the Extension office within 10 days after the weigh-in - Tuesday, April 15.

840 Tags numbers for Breeding Swine projects must be reported by May 15.

### Lamb & Meat Goat Weigh-In



The Saline County 4-H Lamb and Goat Weigh-Ins will be held on Saturday, **May 3** at **1:00 pm** at the Fairgrounds. 4-H members enrolled in Market Sheep or Market Goat projects who want to participate in the Saline County Rate of Gain Contests should plan to attend.



Goats - Wethers born September to February must be banded or castrated by weigh-in. March-born wethers must be banded or castrated by **June 30** and reported to the Goat Superintendent. All bucks born April to fair must show in breeding buck classes.

The required Scrapie tag must be in the animal's ear before the weigh-in.

Market Lamb and Goat projects not weighed for Rate of Gain must be tagged with an Scrapie tag and reported to the Extension office within 10 days after the weigh-in - Tuesday, May 13.

Scrapie Tags numbers for Breeding Sheep and Goat projects must be reported by May 15.

## **Important Livestock Tagging Changes**

We are no longer using the A and B Tags for Rate of Gain and Non-Rate of Gain. We will use the required 840 tags for Beef and Swine projects and the required Scrapie tags for Goat and Lamb projects.

#### **MARKET ANIMALS** - Rate of Gain and Non Rate of Gain

RATE OF GAIN - 840 Tags for Cattle and Swine projects and Scrapie Tags for Goat and Lamb projects must be placed in animal's ear before weigh-in.

NON RATE OF GAIN (all Market Animals) - 840 Tag (Cattle or Swine) or Scrapie Tag (Goats or Lambs) must be placed in the animal's ear and the number turned in to the Extension office within 10 days of weigh-in.

<u>BREEDING ANIMALS</u> - 840 Tag number (Cattle - including Dairy - or Swine) or Scrapie Tag number (Goats or Lambs) must be entered on the Livestock Registration Form and turned in to the Extension Office by May 15.

All Breeding and Market Livestock Projects (Beef, Swine, Sheep, Goats, and including Dairy Cattle and Rabbits) must be entered on the Livestock Registration Form by May 15<sup>th</sup> - No Exceptions. (Report Tattoo # for Rabbits)

#### Horse & Pony Validation Forms Due May 1

Saline County 4-H Horse & Pony Project Validation Forms (along with photos of your horse if you plan to show at State Fair) will be due in to the Extension office no later than May 1.

Youth will need to fill out one copy per horse that you may possibly bring to the show.

Horse & Pony Validation forms are available at the Extension Office. Call to request a copy.

All Exhibitors must have a completed **4-H Lifetime Release from Liability** form on file at the Extension office or have signed the form electronically in ZSuite. **Helmets are required for all 4-H Horse & Pony mounted exhibitors in or out of the show ring.** 



### Stockmen's Youth Rabbit Show & Clinic

The Saline County Stockmen's Association is sponsoring a Youth Rabbit Show & Clinic on **Saturday**, **May 10**, **2025**, at the Saline County Fairgrounds. Registration begins at 9:30 am and the Show will begin promptly at 10 am. This show is open to all youth ages 6-19.

There will be 3 placings in each class, along with awards for Best of Breed and Overall Grand and Reserve Champion. There will be giveaways and drawings for prizes. There is no entry fee. This is a clinic, so bring your questions for the judge. Topics covered include: Nail Trimming, Grooming, Handling, Ear Mites, Sexing Rabbits, Showmanship, and Breed Facts.

This is your opportunity to tattoo your rabbits for the Saline County 4-H Rabbit Show in July. ### Saline County Farm Bureau 2025 4-H Project Grant

The Saline County Farm Bureau is offering 4-H Project Grants again this year. <u>All</u> 4-H members <u>ages 8-18</u> are eligible to apply.



This grant program is designed to provide financial support to younger 4-H members to purchase materials needed to complete a successful 4-H project.

Grants will be awarded in amounts ranging from a minimum of \$25 - \$125. There is a limit of one grant per 4-H member per year.

Applications were emailed to all eligible youth, and additional copies are available at the Extension Office. Youth must have completed their enrollment in 4-H in order to be eligible. Applications are due by June 1, 2025 and must be signed by the 4-H Club Leader and a parent/guardian. All purchases must be made prior to exhibition at a Saline County 4-H Show, and receipts and a photo of items purchased must be submitted no later than July 18, 2025.

We encourage youth to apply for a project grant. It could be a great help with your project expenses.
