

QUALITY ASSURANCE & ETHICS (QA&E):

The Quality Assurance and Ethics training is required for all youth that enroll in horses, rabbits, poultry, dogs, and cats. Members must take the training whether they own a live animal or not. It is advised that they complete this one time as soon as they are enrolled in the project area. Counties will monitor completion of this. Failure to complete QA&E will result in the member's animal science project enrollment being cancelled and they will be ineligible to exhibit at county fairs. NOTE: Youth must be logged on to a computer for this program, either a desktop or laptop; not an iPad or iPhone. The program cannot capture the information for county staff to see if it is completed using iPads or iPhones.

Due to Covid, some of the guidelines have been changed for this year. With it being an incomparable past year, the Jasper County 4-H Foundation has voted to cover all program fees for Jasper County 4-H members! Livestock Tags

All livestock animals (swine, beef, dairy, sheep, goats, and market animals) **must** be tagged no later than April 30, 2021 in order to show at the 2021 Jasper County 4-H Shows. Crossbred animals tagged in a previous year with Jasper tags do not have to be re-tagged, but should be listed on the tagging form. Purebred livestock must be property of the exhibitor by the latest ownership date (check your 4-H Handbook for ownerships dates). Tags and tagging forms are available to be picked up at the Extension office on the following dates/times:

March 9, 10 AM-7 PM

March 10, 9 AM-4 PM

March 16-17, 9 AM-4 PM

March 18, 4:30-6:30 PM

March 23-25, 9 AM-4 PM

March 30-31, 9 AM-4 PM

Normal office hours of Monday-Friday, 8:30 AM-4:30 PM is expected to begin April 1.

Livestock Ownership Deadlines

All small animals and livestock must be owned by April 30 in order to show at the Jasper County 4-H Shows in June. Members planning to show at the Illinois State Fair must follow their specific guidelines. Illinois 4-H outlines safety requirements for in-person events

We're looking forward to seeing you in 2021! As Illinois 4-H staff plan for the 2021 show and event season, our top priority will continue to be the safety of all involved, combined with a commitment to creating positive youth development experiences for our 4-H members.

The opportunity for face-to-face judging for Clay, Effingham, Fayette, and Jasper Counties will require that all participants, spectators, and volunteers adhere to Illinois 4-H event guidelines. We are counting on our 4-H members, their families, and our staff and volunteers to do their part to help make our upcoming events as safe as possible. By working together, we hope to return to face-to-face judging, but it only works if we are all equally committed to following essential COVID-19 mitigation strategies.

The following COVID-19 social distancing and safety practices reflect requirements of the Illinois Department of Public Health and University of Illinois event guidelines. These mitigation protocols also may be modified to reflect any requirements of the local public health department based on local conditions at the time of the event.

- 1. Face coverings are required for all youth, spectators, volunteers, and staff.
- 2. Everyone in attendance will practice social distancing during the event, including maintaining six feet of separation (both indoors and outdoors) from those who are not in their households. To allow for social distancing, building and spectator capacity may be limited based on current public health department guidelines.
- 3. Handwashing and sanitizing stations will be provided throughout the venue.
- 4. Anyone who has experienced COVID-19 symptoms within the previous seven days is asked to stay home. COVID-19 symptoms include fever, cough, loss of taste or smell, or shortness of breath.

As excited as we are about the chance to step back into face-to-face judging, we also recognize that this is a continually evolving situation. Illinois 4-H reserves the right to adjust or cancel events in the case of identified risk, such as changes in local COVID conditions or known instances of non-compliance with safety guidelines.

We truly are stronger together. With your help, we look forward to a safe and successful summer!



















