Auction:

Only Beef and Swine Live animals may be purchased and sent to Eickmans for 2021. For all other animals, 4-H members will retain ownership and sold at a premium rate.

Transportation to Eickmans will be provided only for beef and swine who are not being retained ownership.

A floor price will be set according to the current market trends the day of the auction. A list of current market prices will be available.

Pork and lamb carcasses will be sold whole. Beef carcasses will be sold in halves.

4-H exhibitors who retain ownership of their show animals to show at other fairs throughout the summer. When this happens in 2021, buyers will only pay the difference between their bid and market price. To illustrate, if market price is \$.60 per pound and you bid \$.80 per pound, the difference would be \$.20 per pound. You would pay the virtual auction site \$.20 per pound and leave the auction without further business to transact.
