Illinois 4-H outlines safety requirements for in-person events
We're looking forward to the 2021 season! As Illinois 4-H staff plan for the 2021 show and event season, our top priority will continue to be the safety of all involved, combined with a commitment to creating positive youth development experiences for our 4-H members.

We are preparing for the possibility of returning to in-person events, based on local conditions at that time and in conjunction with current IDPH guidelines.

If current local conditions are conducive to in-person events, the opportunity for face-to-face judging for Shelby County will require that all participants, spectators, and volunteers adhere to Illinois 4-H event guidelines. We are counting on our 4-H members, their families, and our staff and volunteers to do their part to help make our upcoming events as safe as possible, whatever format they take.

The following COVID-19 social distancing and safety practices reflect requirements of the Illinois Department of Public Health and University of Illinois event guidelines. These mitigation protocols also may be modified to reflect any requirements of the local public health department based on local conditions at the time of the event.

- Face coverings are required for all youth, spectators, volunteers, and staff when within the defined 4-H event space (inside or outside)
- Everyone in attendance will practice social distancing during the event, including maintaining six feet of separation (both indoors and outdoors) from those who are not in their households. To allow for social distancing, building and spectator capacity may be limited based on current public health department guidelines.
- Handwashing and sanitizing stations will be provided throughout the venue.
- Anyone who has experienced COVID-19 symptoms within the previous seven days is asked to stay home. COVID-19 symptoms include fever, cough, loss of taste or smell, or shortness of breath.

If any of these guidelines presents a challenge for you, please contact us directly at 217-774-9546. We are happy to discuss what accommodations are possible so that we can look for ways that all youth can safely participate in this event.

As excited as we are about the possibility of stepping back into face-to-face judging, we also recognize that this is a continually evolving situation. Illinois 4-H reserves the right to adjust or cancel events in the case of identified risk, such as changes in local COVID conditions or known instances of non-compliance with safety guidelines.





2021 Exhibition Livestock Health Requirements County Fairs

GENERAL REQUIREMENTS - These Exhibition Health Requirements apply to all livestock present at the fair including those animals that are not entered in competitive events.

- 1. Exhibitors are required to familiarize themselves with all rules applicable to their exhibits. All out-of-state animals shall require an entry permit. Entry permit numbers are available by calling the Illinois Department of Agriculture, Monday through Friday from 8:00 AM to 4:30 PM, at 217/782-4944. Permits may also be obtained online at: http://www.agr.state.il.us/AnimalHW/animalregistry/login.php
- 2. All animals, except as noted, shall be accompanied by a Certificate of Veterinary Inspection (CVI) which shows that the animal meets all health requirements for the State of Illinois. CVI's shall be made available to Bureau of Animal Health Personnel on request.

CVI means a legible record made on an official form from the state of origin which has been issued, signed and dated by an accredited veterinarian and which shows the name and address of the animal's owner or exhibitor and the results of all required tests or vaccinations. A CVI shall list only one animal identification per line; shall be presented on the form on which it was initially issued; and shall not be corrected, changed or altered in any manner.

- 3. All animals shall be officially identified. The animal(s) official identification shall be recorded on the CVI.
- 4. If animals are from tuberculosis accredited, brucellosis certified, pseudorabies qualified, or brucellosis validated herds, the identifying herd number(s) along with the date of the last herd test(s) shall appear on the CVI.
- 5. CVI for out-of-state livestock shall be void thirty (30) days after issuance.
- 6. CVI for Illinois-origin livestock shall be void ninety (90) days after issuance.
- 7. All livestock shall be subject to examination upon entry to any Illinois fair or exhibition. Any animal showing evidence of infectious, contagious or communicable diseases shall be immediately withdrawn and held in quarantine at the owner's risk and expense until properly treated and recovered, or until the animal is released to return to the owner's premise.

Any livestock infected with scabies, mange, active lesions of ringworm, soremouth, or multiple warts which are easily visible without close examination shall not be permitted to exhibit and are subject to quarantine or removal from the fairgrounds.

Sheep and goats with caseous lymphadenitis as evidenced by draining abscesses shall not be exhibited and are subject to immediate quarantine or removal from the fairgrounds.

- 8. Illinois Department of Agriculture personnel or designee may collect blood, tissue, milk or urine samples from any animal being exhibited and/or raced at any Illinois fair to test for the presence of illegal drugs or banned substances. New examination techniques, such as ultrasound, may also be used at anytime while the animals are on the grounds of any Illinois fair or exhibit. The Illinois Department of Agriculture or designee may collect urine, blood, tissue or other test samples from exhibition animals at the time of slaughter.
- 9. All exhibitors of animals at any Illinois fair or exhibition shall comply with the provisions of the Illinois Humane Care for Animals Act. If violations are observed, the animals(s) will be excused from exhibition and ordered removed from the grounds with all awards being forfeited. Any practice or deviation from normal, accepted care, including physical, medical or mechanical application, shall constitute a violation of show rules and may result in the animal(s) disqualification and removal from the fairgrounds.
- 10. Any Illinois cattle, bison, cervidae or goats being exhibited in non-accredited free states must be isolated from the remainder of the herd/flock upon return to Illinois and retested for tuberculosis 60-120 days post-entry.

CATTLE

Identification

Individual identification of each animal shall be either a fully healed and legible tattoo, approved official ear tag, registration number (can only be used if the tattoo is recorded on the registration certificate or for breeds where pictures are acceptable), or individual brands, if brand is recorded on the registration certificate.

Illinois Cattle

Brucellosis - Illinois is a Bovine Brucellosis Class-Free State. Brucellosis testing is not required for Illinois cattle.

Tuberculosis—Illinois is an Accredited Tuberculosis- Free State. Tuberculin testing is not required for Illinois cattle.

Please note: Illinois calves under 6 months of age, and Illinois steers are not required to have a Certificate of Veterinary Inspection.

Out-of-State-Cattle

All out-of-state cattle are to be accompanied by an entry permit. Entry permit numbers are available by calling the Illinois Department of Agriculture, Monday through Friday from 8:00 AM to 4:30 PM, at 217/782-4944. Permits may also be obtained online at: http://www.agr.state.il.us/AnimalHW/animalregistry/login.php

Brucellosis

- Female cattle six (6) months of age and older and bulls eighteen (18) months of age and older shall be negative to an official test for brucellosis within thirty (30) days prior to entry, unless exempt by one (1) of the following:
 - A. Originate directly from a certified brucellosis-free herd.
 - B. Official vaccinates of dairy breeds under twenty (20) months of age or official vaccinates of beef breeds under twenty-four (24) months of age.
 - C. Animal originated from a "Class Free" state (if entire state is so classified)
 - D. Steers and spayed heifers are not required to be tested for brucellosis.
- The negative brucellosis test shall be conducted at a state or federal laboratory within 30 days prior to exhibition.

Tuberculosis

- 1. Accredited Tuberculosis Free States
 - A. No tuberculin test required. All cattle, including steers, originating from an Accredited Tuberculosis Free State, may enter Illinois for exhibition when accompanied by a CVI issued by an accredited veterinarian within 30 days.
- 2. Non-Accredited Tuberculosis Free Areas or States (Not TB Free)
 - A. Cattle must originate from a herd where a complete herd test was conducted within the past year.
 - B. The individual animals entering Illinois must be negative to an additional tuberculin test conducted within 30 days prior to exhibition.
 - C. Cattle that enter Illinois for exhibition and remain in Illinois (animal does not return to the state of origin within 30 days) must be isolated and retested for TB 60-120 days from the last official TB test
- PIGEONS There are no requirements governing the movements of pigeons within or into Illinois.
- RABBITS There are no requirements governing the movements of rabbits within or into Illinois.

SWINE

Illinois Swine

Identification

Swine shall be identified by an official ear tag, tattoo or recognized breed ear notch.
 Ear notch identification is acceptable for all barrows, crossbred gilts and breeding swine.
 (Note: Ear notch identification of crossbred swine does not satisfy USDA identification requirements for interstate movement or official testing.)

Brucellosis - Brucellosis testing is not required for Illinois swine.

Pseudorabies-Pseudorabies testing is not required for Illinois swine.

Out-of-State Swine

All out-of-state swine are to be accompanied by an entry permit. Entry permit numbers are available by calling the Illinois Department of Agriculture, Monday through Friday from 8:00 AM to 4:30 PM, at 217/782-4944. Permits may also be obtained online at: http://www.agr.state.il.us/AnimalHW/animalregistry/login.php

Identification

- 1. Individually identified by an official ear tag, tattoo or recognized breed ear notch.
- 2. Ear notch identification is not acceptable for crossbred animals.

Brucellosis

- 1. Breeding swine 4 months of age and older shall be negative to an official test for brucellosis within 30 days prior to exhibition unless exempt by one (1) of the following:
 - A. Originate immediately and directly from a validated brucellosis-free herd.
 - B. Originate directly from a validated brucellosis-free state.
- 2. Swine brucellosis tests for exhibition shall be conducted at a state or federal laboratory.

Pseudorabies

- Swine originating from a Pseudorabies Stage IV or V state are exempt from the pseudorabies testing requirement.
- Swine originating from a Pseudorabies Stage III state shall be negative to an official test for pseudorabies conducted within thirty (30) days prior to entry or originate immediately and directly from a qualified pseudorabies negative herd.
- Swine originating from a Pseudorabies Stage I or II state shall be negative to an official test for pseudorabies conducted within the 10 days prior to entry.
- 4. Barrows and females in market classes must meet the same requirements as breeding swine.

SHEEP

Identification

Individual identification of each animal shall be by an ear tattoo or official metal or plastic tag. A microchip ID is acceptable if the owner provides the reader.

Ear tattoos may be used when a registration certificate, listing the tattoo number, accompanies the animal.

When using ear tags, the tag must indicate the premises ID and state of origin. The tag number must be assigned by a state or APHIS representative and recorded in the Scrapie Record Database.

Market Lambs

All market lambs must be slick shorn (show ring ready) before weigh-in so that show lamb fungus can be identified.

Illinois Sheep

- 1. Sheep originating from a flock that has previously been classified as either an infected or source flock can be exhibited in Illinois upon the completion of an approved flock plan.
- For any animal born after 1/1/2002, the CVI must include the flock of birth and the flock of origin, if different.

Out-of-State Sheep

All out-of-state sheep are to be accompanied by an entry permit. Entry permit numbers are available by calling the Illinois Department of Agriculture, Monday through Friday from 8:00 AM to 4:30 PM, at 217/782-4944. Permits may also be obtained online at: http://www.agr.state.il.us/AnimalHW/animalregistry/login.php

- 1. Sheep originating from a flock that has previously been classified as either an infected or source flock can be exhibited in Illinois upon the completion of an approved flock plan.
- 2. For any animal born after 1/1/2002, the CVI must include the flock of birth and the flock of origin, if different.

GOATS

Identification

Individual identification of each animal shall be by an ear tattoo or official metal or plastic tag. A microchip ID is acceptable if the owner provides the reader.

Tattoos may be used when a registration certificate, listing the tattoo number, accompanies the animal.

When using ear tags, the tag must indicate the premises ID and state of origin. The tag number must be assigned by a state or APHIS representative and recorded in the Scrapie Record Database.

Ears should be used for tattooing when possible. If there is no space in the ear, the flank or tail fold may be used.

Illinois Goats

- 1. Goats originating from a herd that has previously been classified as either an infected or source herd can be exhibited in Illinois upon the completion of an approved herd plan.
- 2. For any animal born after 1/1/2002, the CVI must include the flock of birth and the flock of origin, if different.

Out-of-State Goats

All out-of-state goats are to be accompanied by an entry permit. Entry permit numbers are available by calling the Illinois Department of Agriculture, Monday through Friday from 8:00 AM to 4:30 PM, at 217/782-4944. Permits may also be obtained online at: http://www.agr.state.il.us/AnimalHW/animalregistry/login.php

- 1. Goats originating from a herd that has previously been classified as either an infected or source herd can be exhibited in Illinois upon the completion of an approved herd plan.
- 2. Tuberculosis- Goats from areas or states that are not Accredited Bovine Tuberculosis Free, must be accompanied by a CVI indicating that the goats originated from a herd where a complete negative herd test has been conducted within the past twelve (12) months and the individual animals are negative to a tuberculin test conducted within thirty (30) days prior to entry. For any animal born after 1/1/2002, the CVI must include the flock of birth and the flock of origin, if different.

HORSES, PONIES, MULES AND OTHER EQUIDAE

Illinois Equine

- 1. All horses and other equidae, twelve (12) months of age and older attending an advertised equine event, shall be accompanied by a negative test for equine infectious anemia (EIA) conducted within the last twelve (12) months. A copy of this test shall accompany the animal.
- 2. AGID (Coggins) or ELISA tests are accepted.
- 3. An advertised equine event means a show, rodeo, sale, auction, exhibition, trail ride, or horse fair that is posted or media promoted.
- 4. A CVI is not required for Illinois equine.

Out-of-State Equine

All out-of-state equine are to be accompanied by an entry permit. Entry permit numbers are available by calling the Illinois Department of Agriculture, Monday through Friday from 8:00 AM to 4:30 PM, at 217/782-4944. Permits may also be obtained online at: http://www.agr.state.il.us/AnimalHW/animalregistry/login.php

- 1. All horses and other equidae entering Illinois that are twelve (12) months of age or older, shall be accompanied by a negative test for equine infectious anemia (EIA) conducted within the last twelve (12) months. A copy of this test shall accompany the animal.
- 2. AGID (Coggins) or ELISA tests are accepted.
- 3. All horses and other equidae shall be accompanied by a CVI issued within thirty (30) days prior to entry.

POULTRY

- 1. All entries (except waterfowl, i.e. domesticated fowl that normally swim, such as ducks and geese) in a show or exhibition shall have originated from a U.S. Pullorum-Typhoid Clean or equivalent hatchery or flock OR have a negative pullorum-typhoid test within 90 days prior to exhibition. Exhibitor shall show proper information as to name and address of owner or exhibitor, name and address of the authorized testing agent, date of the testing and the number, breed, and species of those tested.
- 2. Prior to being used to transport poultry to a show, all crates, boxes, containers and vehicles shall be thoroughly cleaned and disinfected.
- 3. Any poultry vaccinations must be performed at least 4 weeks prior to delivery to the show.
- 4. Upon admission to a show, all entries shall be examined by the official county fair veterinarian or qualified state personnel who shall also receive and examine all certificates necessary for admission of birds to a show. Birds not in show condition will be excused from exhibition and removed from the premises. Any fowl showing signs of illness during the fair will be removed from the exhibition grounds.
- 5. All out-of-state turkeys must originate from flocks that are officially classified as U.S. Mycoplasma Gallisepticum Clean in accordance with the provisions of the National Poultry Improvement Plan or be negative to a test for Mycoplasma gallisepticum within 30 days prior to entry.
- 6. A permit is also required for out-of-state poultry. A permit may be obtained by calling (217) 782-4944.

Please note: These poultry exhibition requirements do not apply to 4-H and FFA 1-day poultry shows where the entries are taken to the show and returned home the same day. However, a permit is required for out-of-state poultry.

The Illinois Department of Agriculture administers State Statutes relating to fairs and agricultural exhibitions, including the Shelby County 4-H and Junior Fair.

Technically, the 4-H Fair and Junior Fair are separate events that are held concurrently and in the same location at the Shelby County 4-H and Junior Fairgrounds. Youth enrolled in University of Illinois Extension's 4-H youth development program in Shelby County are eligible to exhibit their projects in the 4-H Fair, and to receive educational feedback from judges as part of this "culminating event" for their project efforts. Participation in Junior Fair classes is not restricted to 4-H members; all Shelby County youth between 8 and 18 years of age, including FFA members who are not enrolled in 4-H, are eligible to compete in Junior Fair classes.

For purposes of awarding premiums, the Illinois Department of Agriculture requires fair organizers to make clear distinctions between 4-H Fair classes and comparable Junior Fair classes. It is important for us to comply with the law, as fairs are subject to spot-checks by Department of Agriculture regulatory staff and penalties for not clearly distinguishing between Junior Fair and 4-H Fair classes may include loss of **all** exhibitor premiums. Here are a few of the ways in which we demonstrate our fairs' compliance:

- The Fair book, which is funded and produced jointly by 4-H and Junior Fair organizers, lists separate classes for 4-H and Junior Fair exhibits and separate entries are required.
- All 4-H Fair entries are processed by University of Illinois Extension staff, while Junior Fair entries must be processed by volunteers affiliated with the Junior Fair. As a convenience to exhibitors who enter projects in both 4-H and Junior Fair classes, the local Extension office will accept paper copies of Junior Fair entries and hold them in a separate box until a Junior Fair volunteer can collect and process them.
- On show day, judging/awards for Junior Fair livestock classes will take place immediately after the comparable 4-H Fair classes, with sufficient time allowed for any additional Junior Fair exhibitors and animals to enter the show ring and be judged. (Youth who exhibit in both classes will not be required to leave the show ring in-between classes.)

We appreciate your cooperation in ensuring that our fairs operate within State law.

SHELBY COUNTY YOUTH LIVESTOCK AUCTION

THE SHELBY COUNTY JR. FAIR BOARD IS IN CHARGE OF THE AUCTION.

The 2021 Shelby County Youth Livestock Auction will be a non-terminal sale. All auction items will sell by the head/pen. What does this mean to 4-H families? The 4-H member will retain ownership of their animal following the auction and will receive a premium from the buyer. The 4-H member is responsible for taking their animal home. The successful buyer will not take ownership of the animal. Arrangements for purchasing the animal are strictly between the buyer and the seller after the auction has concluded.

- 1. Please be advised that while the Jr. Fair Board promotes the auction thru advertising, personal contact and mailing over 200 letters to prospective buyers, we need help. Exhibitors should try to secure prospective bidders for their animals in the auction. Parents and participants please contact your banker, insurance agent, etc. and ask them to attend the auction. The auction showcases all the hard work and effort by 4-H'ers. Businesses can not possibly purchase from all their customers but it is important for them to be invited and welcomed to the auction.
- To be eligible for the premium sale, livestock must be exhibited in a 4-H market livestock class (breeding, showmanship classes do not qualify). In the Poultry, Rabbit, and Dairy divisions, only the Grand Champion and Reserve Grand Champion Pen of 3 Market Birds, Pen of 3 Market Rabbits, and Overall Dairy may sell.
- 3. A 4-H'er can sell only one exhibit, unless he/she exhibits more than one grand champion or reserve grand champion.
- 4. The Shelby County Jr. Fair Board reserves the right to deny an exhibitor's participation in the sale as they see fit. The Auction is in no way associated or managed by the U of I Extension.
- 5. Only 4-H members are eligible to participate. The 4-H'er and their animal must go through the sale ring. Parents and superintendents shall assist 4-H'ers in getting the animal to the sale ring.
- 6. The Sale will start at 6:30 p.m. on Wednesday night of the Fair.
- Market Beef and Dairy Beef must be broke to lead and led into ring by the 4-H exhibitor in order to sell.
- 8. 4-H members will have their photo taken before going through the sale ring. Photographs of seller, buyer and animal may be taken after the sale at the request of the buyer. 4-H members are responsible for writing a thank you note and delivering a copy of the picture to the buyer within one month.
- 9. 2% will be taken out of all checks to cover the cost of photo and auction costs. NO REFUNDS!!
- 10. 4-H members must attend at least three of their own 4-H club meetings (college students must attend 2 meetings), give a talk or demonstration related to a 4-H project and attend one county activity besides the fair to be eligible to sell an animal at the 4-H Auction. 4-H'ers must also have completed the Youth for the Quality Care of Animals (YOCA).
- 11. Auction checks may be held for up to 6 weeks following the auction.

4-H'ers must sign up in the Fair Office listing which animal they are selling.

Poultry, Rabbit exhibitors—Grand Champion and Reserve Grand Champion must sign up within a half hour after their shows.

Dairy exhibitors—Ice Cream—Grand Champion and Reserve Grand Champion must sign up by 5 p.m. Tuesday.

Sheep exhibitors must sign up by 2 p.m. Monday.

Dairy Beef and Dairy Bucket Calf exhibitors must sign up by 5 p.m. Tuesday.

Goat exhibitors must sign up by 9 a.m. Tuesday.

Swine exhibitors must sign up by 2 p.m. Tuesday.

Beef and Bucket Calf exhibitors must sign up within a half hour after the Beef Show ends.

NOTE: The Fair Board is not responsible for the load out of any livestock. Arrangements for all animals are the responsibility of the 4-H family. NO EXCEPTIONS!

JUNIOR FAIR RULES

DISCLAIMER—"The Department of Agriculture shall use its best efforts to secure sufficient appropriations to fund premiums. In any year for which the General Assembly of the State of Illinois fails to make an appropriation sufficient to pay such premiums, premium amounts may not be accurately reflected in this Premium Book."

Each Junior Fair livestock class will be judged and ribbons awarded shortly after the conclusion of the comparable 4-H Fair class.

Entry fees will be deducted from premiums. No fees will be charged to an entry not paid a premium.

- 1. ALL ENTRIES MUST BE IN THE EXTENSION OFFICE BY JUNE 4.
- Entries are open only to boys and girls who live in Shelby County or belong to Shelby County
 4-H and are at least 8 years old by September 1, 2020, but have not passed their 19th birthday
 by September 1, 2021.
- 3. For the 2021 fair, general projects must be the work of the individual making the exhibit. (September 1, 2019 thru fair date).
- 4. **Animals showing at the Shelby County Jr. Fair** Completion of the Quality Assurance & Ethics training (QAEC) is required for all Shelby County exhibitors in the cats, dogs, horse/pony, rabbit and poultry classes. Those who have previously taken the QAEC training are maintained on the approved list and will not need to be re-certified. Online training is available at http://web.extension.uiuc.edu/qaec/ and must be taken by June 4 in order to exhibit in the Jr. Fair.
- Animals showing at the Shelby County Jr. Fair –Completion of the Youth For the Quality Care of Animals (YCQA) is <u>required</u> for all Shelby County exhibitors in the beef, dairy, sheep, swine, and goat classes. 4-H members must complete a Face to Face training or Online training by June 4.
- 6. All animals showing in breeding classes must be registered in the name of the exhibitor by June 4 of this year. Registry certificates of ownership or transfer must be produced, showing exhibitor to be the owner, when called for by the superintendent.
- 7. Horse and pony: By May 1 of the exhibit year, exhibitors must place on file at the local Extension Office copies of ownership and/or lease papers for all animals that the member may plan to exhibit at the Junior Horse Shows. In addition to the ownership/lease papers, two photos (one of each side) of animals will be mandatory for all horse and ponies, grade and registered animals. No animal may be shown more than twice in any of the livestock divisions, except horses and sheep.
- 8. Only animals entered and stabled on the show premises can compete for any of the premiums offered, excluding horses/ponies.
- 9. No artificial coloring will be allowed in livestock classes. Cattle are to be shown in their natural conformation. The use of FALSE TAIL HEADS is prohibited. The addition of HAIR, HEMP or ANY SIMILAR SUBSTANCE to any part of an animal is prohibited.
- 10. No animal may be drugged or it will be disqualified.
- 11. All market beef must have milk teeth in place. Age will be determined by mouthing.
- 12. No animals can be sold on the Fairgrounds unless it is being exhibited.
- 13. All exhibits must be shown by the owner or by another 4-H member.
- 14. An exhibitor must show in each class in which he is entered unless special permission is granted by the superintendent. No class switching is allowed.
- 15. If only one exhibit is entered in a class, the exhibit, if shown, will receive first premium. Exhibitors will be limited to two premiums per class.
- 16. All livestock exhibitors must have their entries in place by Sunday, July 18 at 8 p.m. No entries shall be removed until Wednesday, July 21 at 9:30 p.m. Any exhibitor failing to comply with the above rules will forfeit their premiums won during the fair.
- 17. 4-H Center and Produce Building exhibitors need to check their project area for their check-in time. Release will be on Wednesday, July 21 from 9-10 p.m. and Thursday

morning at 8 a.m. Any exhibitor failing to comply with the above rules will forfeit their premiums won during the fair.

- 18. Pens and stalls will be assigned. Assignments will be made by the department superintendents, and all exhibitors are expected to comply with assignments.
- 19. Health papers will be checked on Sunday, July 18 from 7-8:00 p.m. in the Fair Office. Exhibitors must have registration papers with them at all times.
- 20. The fair reserves the right to refuse permission for the entry to show if any entry is not considered worthy of merit.
- 21. Each exhibitor is responsible for their own feeding, equipment, and bedding and must keep their pen and exhibits in good order. The fair is yours, and it will be up to you to keep your pens in good shape.
- 22. The interpretation on all rules concerning the fair shall rest entirely with the Fair Board, and its decision shall be final. Illinois State Fair Junior Department rules will apply to all situations not covered by these rules.
- 23. The Fair Board reserves the right to bar any exhibitor for violation of rules by deceptive practices.
- 24. The Junior Fair Board and Extension Office will not be responsible for exhibitors' projects that are lost or stolen.
- 25. Shelby County Junior Fair will provide watchmen to guard exhibits, but will not be held responsible for personal loss or injury from fire or theft or any other causes during the duration of the fair.
- 26. <u>NO ALCOHOL</u> allowed on fairgrounds. If caught with alcohol, exhibitors will not be allowed to show or receive premium money.
- 27. No smoking allowed in any Livestock Barns.
- 28. The fairgrounds are located at the junctions of North Sixth Street and Route 128 at the northwest edge of Shelbyville.
- 29. The fair gates open to the public at 7:30 a.m. daily. The fairgrounds will be closed at 11:00 p.m. each night.
- 30. The Illinois Humane Care for Animals Act will be enforced. Basically, this act prohibits physical mistreatment of animals. Persons found mistreating animals shall be prohibited from exhibiting and may be dismissed from the fairground.
- 31. No camping allowed on the fairgrounds.
- 32. Unsportsmanlike conduct by exhibitor shall be cause for dismissal of the exhibitor from the fair.
- 33. Neck ties are required on all beef tie-outs.
- 34. No Butt fans are allowed on fairgrounds.
- 35. Trophy winners: Remember to write thank-you letters to your donor.

- 14. All beef steers and market heifers must have been weighed at county weigh-in on **February 6, 2021** 15. NO BUTT FANS ARE ALLOWED IN THE BARN.
