Illinois 4-H outlines safety requirements for in-person events

We're looking forward to the 2021 season! As Illinois 4-H staff plan for the 2021 show and event season, our top priority will continue to be the safety of all involved, combined with a commitment to creating positive youth development experiences for our 4-H members.

We are preparing for the possibility of returning to in-person events, based on local conditions at that time and in conjunction with current IDPH guidelines.

If current local conditions are conducive to in-person events, the opportunity for face-to-face judging for Shelby County will require that all participants, spectators, and volunteers adhere to Illinois 4-H event guidelines. We are counting on our 4-H members, their families, and our staff and volunteers to do their part to help make our upcoming events as safe as possible, whatever format they take.

The following COVID-19 social distancing and safety practices reflect requirements of the Illinois Department of Public Health and University of Illinois event guidelines. These mitigation protocols also may be modified to reflect any requirements of the local public health department based on local conditions at the time of the event.

- Face coverings are required for all youth, spectators, volunteers, and staff when within the defined 4-H event space (inside or outside)
- Everyone in attendance will practice social distancing during the event, including maintaining six feet of separation (both indoors and outdoors) from those who are not in their households. To allow for social distancing, building and spectator capacity may be limited based on current public health department guidelines.
- Handwashing and sanitizing stations will be provided throughout the venue.
- Anyone who has experienced COVID-19 symptoms within the previous seven days is asked to stay home. COVID-19 symptoms include fever, cough, loss of taste or smell, or shortness of breath.

If any of these guidelines presents a challenge for you, please contact us directly at 217-774-9546. We are happy to discuss what accommodations are possible so that we can look for ways that all youth can safely participate in this event.

As excited as we are about the possibility of stepping back into face-to-face judging, we also recognize that this is a continually evolving situation. Illinois 4-H reserves the right to adjust or cancel events in the case of identified risk, such as changes in local COVID conditions or known instances of non-compliance with safety guidelines.

2021 Exhibition Livestock Health Requirements County Fairs

GENERAL REQUIREMENTS - These Exhibition Health Requirements apply to all livestock present at the fair including those animals that are not entered in competitive events.

1. Exhibitors are required to familiarize themselves with all rules applicable to their exhibits. All out-of-state animals shall require an entry permit. Entry permit numbers are available by calling the Illinois Department of Agriculture, Monday through Friday from 8:00 AM to 4:30 PM, at 217/782-4944. Permits may also be obtained online at: http://www.agr.state.il.us/AnimalHW/animalregistry/login.php

2. All animals, except as noted, shall be accompanied by a Certificate of Veterinary Inspection (CVI) which shows that the animal meets all health requirements for the State of Illinois. CVI's shall be made available to Bureau of Animal Health Personnel on request.

CVI means a legible record made on an official form from the state of origin which has been issued, signed and dated by an accredited veterinarian and which shows the name and address of the animal's owner or exhibitor and the results of all required tests or vaccinations. A CVI shall list only one animal identification per line; shall be presented on the form on which it was initially issued; and shall not be corrected, changed or altered in any manner.

3. All animals shall be officially identified. The animal(s) official identification shall be recorded on the CVI.

4. If animals are from tuberculosis accredited, brucellosis certified, pseudorabies qualified, or brucellosis validated herds, the identifying herd number(s) along with the date of the last herd test(s) shall appear on the CVI.

5. CVI for out-of-state livestock shall be void thirty (30) days after issuance.

6. CVI for Illinois-origin livestock shall be void ninety (90) days after issuance.

7. All livestock shall be subject to examination upon entry to any Illinois fair or exhibition. Any animal showing evidence of infectious, contagious or communicable diseases shall be immediately withdrawn and held in quarantine at the owner's risk and expense until properly treated and recovered, or until the animal is released to return to the owner's premise.

Any livestock infected with scabies, mange, active lesions of ringworm, soremouth, or multiple warts which are easily visible without close examination shall not be permitted to exhibit and are subject to quarantine or removal from the fairgrounds.

Sheep and goats with caseous lymphadenitis as evidenced by draining abscesses shall not be exhibited and are subject to immediate quarantine or removal from the fairgrounds.

8. Illinois Department of Agriculture personnel or designee may collect blood, tissue, milk or urine samples from any animal being exhibited and/or raced at any Illinois fair to test for the presence of illegal drugs or banned substances. New examination techniques, such as ultrasound, may also be used at anytime while the animals are on the grounds of any Illinois fair or exhibit. The Illinois Department of Agriculture or designee may collect urine, blood, tissue or other test samples from exhibition animals at the time of slaughter.

9. All exhibitors of animals at any Illinois fair or exhibition shall comply with the provisions of the Illinois Humane Care for Animals Act. If violations are observed, the animals(s) will be excused from exhibition and ordered removed from the grounds with all awards being forfeited. Any practice or deviation from normal, accepted care, including physical, medical or mechanical application, shall constitute a violation of show rules and may result in the animal(s) disqualification and removal from the fairgrounds.

10. Any Illinois cattle, bison, cervidae or goats being exhibited in non-accredited free states must be isolated from the remainder of the herd/flock upon return to Illinois and retested for tuberculosis 60-120 days post-entry.

CATTLE

Identification

Individual identification of each animal shall be either a fully healed and legible tattoo, approved official ear tag, registration number (can only be used if the tattoo is recorded on the registration certificate or for breeds where pictures are acceptable), or individual brands, if brand is recorded on the registration certificate.

Illinois Cattle

Brucellosis - Illinois is a Bovine Brucellosis Class-Free State. Brucellosis testing is not required for Illinois cattle.

Tuberculosis—Illinois is an Accredited Tuberculosis- Free State. Tuberculin testing is not required for Illinois cattle.

Please note: Illinois calves under 6 months of age, and Illinois steers are not required to have a Certificate of Veterinary Inspection.

Out-of-State-Cattle

All out-of-state cattle are to be accompanied by an entry permit. Entry permit numbers are available by calling the Illinois Department of Agriculture, Monday through Friday from 8:00 AM to 4:30 PM, at 217/782-4944. Permits may also be obtained online at: http://www.agr.state.il.us/AnimalHW/animalregistry/login.php

Brucellosis

- 1. Female cattle six (6) months of age and older and bulls eighteen (18) months of age and older shall be negative to an official test for brucellosis within thirty (30) days prior to entry, unless exempt by one (1) of the following:
 - A. Originate directly from a certified brucellosis-free herd.
 - B. Official vaccinates of dairy breeds under twenty (20) months of age or official vaccinates of beef breeds under twenty-four (24) months of age.
 - C. Animal originated from a "Class Free" state (if entire state is so classified)
 - D. Steers and spayed heifers are not required to be tested for brucellosis.
- 2. The negative brucellosis test shall be conducted at a state or federal laboratory within 30 days prior to exhibition.

Tuberculosis

1. Accredited Tuberculosis Free States

A. No tuberculin test required. All cattle, including steers, originating from an Accredited Tuberculosis Free State, may enter Illinois for exhibition when accompanied by a CVI issued by an accredited veterinarian within 30 days.

- 2. Non-Accredited Tuberculosis Free Areas or States (Not TB Free)
 - A. Cattle must originate from a herd where a complete herd test was conducted within the past year.

B. The individual animals entering Illinois must be negative to an additional tuberculin test conducted **within 30 days prior to exhibition**.

C. Cattle that enter Illinois for exhibition and remain in Illinois (animal does not return to the state of origin within 30 days) must be isolated and retested for TB 60-120 days from the last official TB test date.

PIGEONS - There are no requirements governing the movements of pigeons within or into Illinois.

RABBITS - There are no requirements governing the movements of rabbits within or into Illinois.

SWINE

Illinois Swine

Identification

Swine shall be identified by an official ear tag, tattoo or recognized breed ear notch.
 Ear notch identification is acceptable for all barrows, crossbred gilts and breeding swine.
 (Note: Ear notch identification of crossbred swine does not satisfy USDA identification requirements for interstate movement or official testing.)

Brucellosis - Brucellosis testing is not required for Illinois swine.

Pseudorabies-Pseudorabies testing is not required for Illinois swine.

Out-of-State Swine

All out-of-state swine are to be accompanied by an entry permit. Entry permit numbers are available by calling the Illinois Department of Agriculture, Monday through Friday from 8:00 AM to 4:30 PM, at 217/782-4944. Permits may also be obtained online at: http://www.agr.state.il.us/AnimalHW/animalregistry/login.php

Identification

- 1. Individually identified by an official ear tag, tattoo or recognized breed ear notch.
 - 2. Ear notch identification **is not** acceptable for crossbred animals.

Brucellosis

1. Breeding swine 4 months of age and older shall be negative to an official test for brucellosis within 30 days prior to exhibition unless exempt by one (1) of the following:

- A. Originate immediately and directly from a validated brucellosis-free herd.
- B. Originate directly from a validated brucellosis-free state.
- 2. Swine brucellosis tests for exhibition shall be conducted at a state or federal laboratory.

Pseudorabies

- **1.** Swine originating from a Pseudorabies Stage IV or V state are exempt from the pseudorabies testing requirement.
- Swine originating from a Pseudorabies Stage III state shall be negative to an official test for pseudorabies conducted within thirty (30) days prior to entry or originate immediately and directly from a qualified pseudorabies negative herd.
- 3. Swine originating from a Pseudorabies Stage I or II state shall be negative to an official test for pseudorabies conducted within the 10 days prior to entry.
- 4. Barrows and females in market classes must meet the same requirements as breeding swine.

SHEEP

Identification

Individual identification of each animal shall be by an ear tattoo or official metal or plastic tag. A microchip ID is acceptable if the owner provides the reader.

Ear tattoos may be used when a registration certificate, listing the tattoo number, accompanies the animal.

When using ear tags, the tag must indicate the premises ID and state of origin. The tag number must be assigned by a state or APHIS representative and recorded in the Scrapie Record Database.

Market Lambs

All market lambs must be slick shorn (show ring ready) before weigh-in so that show lamb fungus can be identified.

Illinois Sheep

- 1. Sheep originating from a flock that has previously been classified as either an infected or source flock can be exhibited in Illinois upon the completion of an approved flock plan.
- 2. For any animal born after 1/1/2002, the CVI must include the flock of birth and the flock of origin, if different.

Out-of-State Sheep

All out-of-state sheep are to be accompanied by an entry permit. Entry permit numbers are available by calling the Illinois Department of Agriculture, Monday through Friday from 8:00 AM to 4:30 PM, at 217/782-4944. Permits may also be obtained online at: http://www.agr.state.il.us/AnimalHW/animalregistry/login.php

1. Sheep originating from a flock that has previously been classified as either an infected or source flock can be exhibited in Illinois upon the completion of an approved flock plan.

2. For any animal born after 1/1/2002, the CVI must include the flock of birth and the flock of origin, if different.

GOATS

Identification

Individual identification of each animal shall be by an ear tattoo or official metal or plastic tag. A microchip ID is acceptable if the owner provides the reader.

Tattoos may be used when a registration certificate, listing the tattoo number, accompanies the animal.

When using ear tags, the tag must indicate the premises ID and state of origin. The tag number must be assigned by a state or APHIS representative and recorded in the Scrapie Record Database.

Ears should be used for tattooing when possible. If there is no space in the ear, the flank or tail fold may be used.

Illinois Goats

1. Goats originating from a herd that has previously been classified as either an infected or source herd can be exhibited in Illinois upon the completion of an approved herd plan.

2. For any animal born after 1/1/2002, the CVI must include the flock of birth and the flock of origin, if different.

Out-of-State Goats

All out-of-state goats are to be accompanied by an entry permit. Entry permit numbers are available by calling the Illinois Department of Agriculture, Monday through Friday from 8:00 AM to 4:30 PM, at 217/782-4944. Permits may also be obtained online at: http://www.agr.state.il.us/AnimalHW/animalregistry/login.php

1. Goats originating from a herd that has previously been classified as either an infected or source herd can be exhibited in Illinois upon the completion of an approved herd plan.

2. Tuberculosis- Goats from areas or states that are not Accredited Bovine Tuberculosis Free, must be accompanied by a CVI indicating that the goats originated from a herd where a complete negative herd test has been conducted within the past twelve (12) months and the individual animals are negative to a tuberculin test conducted within thirty (30) days prior to entry. For any animal born after 1/1/2002, the CVI must include the flock of birth and the flock of origin, if different.

HORSES, PONIES, MULES AND OTHER EQUIDAE

Illinois Equine

1. All horses and other equidae, twelve (12) months of age and older attending an advertised equine event, shall be accompanied by a negative test for equine infectious anemia (EIA) conducted within the last twelve (12) months. A copy of this test shall accompany the animal.

2. AGID (Coggins) or ELISA tests are accepted.

3. An advertised equine event means a show, rodeo, sale, auction, exhibition, trail ride, or horse fair that is posted or media promoted.

4. A CVI is not required for Illinois equine.

Out-of-State Equine

All out-of-state equine are to be accompanied by an entry permit. Entry permit numbers are available by calling the Illinois Department of Agriculture, Monday through Friday from 8:00 AM to 4:30 PM, at 217/782-4944. North 2nd Street, Shelbyville, (217) 774-9546 at least two weeks prior to the event.

NOTE: In addition to the general 4-H Requirements listed here, rules applying to specific divisions appear in the divisional listings.

Note:

 IRS Requirement—Program participants (including minors) will be required to provide their social security number or foreign national tax ID number prior to receiving a prize, gift or award to ensure IRS reporting as required by law. This sensitive information is kept confidential and handled through security protected software (PEAR). Participants will not be eligible for prize, gift or award if social security or foreign national tax ID information is not provided.

There are three options for exhibiting at the Shelby County 4-H Fair.

- A. In-person conference judging at the designated judging time.
 B. If the 4-H member isn't able to attend due to illness, the 4-H'er may set up a conference call or Zoom meeting at the designated judging time to speak with the judge. The project must be submitted for judging, pictures/videos will not be accepted. Accommodations must be made with Yolanda by July 15.
- C. A Shelby County 4-H member may exhibit a project for another 4-H member who isn't able to attend the fair. The 4-H member not able to attend must complete a project report (ask the Extension office for the form) and submit the form with the project for judging. This project will not be eligible for the State Fair.
- 1. The show is governed by Member Code of Conduct for 4-H Meetings and other 4-H Events and Activities. The Mission of the Illinois 4-H Program is to help youth acquire skills for living. Participation in 4-H programs is a privilege and participants are expected to show respect and cooperation to 4-H leaders and other participants.
 - A. Participants may be removed from 4-H programs or activities for misconduct.
 - B. The possession and use of weapons, drugs, inhalants, tobacco products, alcohol and other illegal substances by 4-H youth participants is prohibited at all 4-H sponsored activities.
 - C. The 4-H program is governed by the Illinois 4-H Behavior Guidelines and Member Code of Conduct which is on file at the Extension Office.
- 2. All exhibitors must be members of Shelby County 4-H. Any person, regardless of race, color, religion, gender, national origin, ancestry, marital status, familial status, sexual orientation, or disability may participate in 4-H programs. Youth who are 8 years of age & have not reached their 19th birthday on or before September 1 of the current 4-H year may enroll in a 4-H club. Persons considered to be mentally challenged & older than the eligibility age for 4-H club membership may participate fully in 4-H. Extension units may allow 4-H enrollment by boys & girls who are 5, 6, or 7 years of age on or before September 1 of the 4-H year. This is a unit decision. If 4-H enrollment is offered to 5-7 year olds, they must be enrolled as 4-H CLOVERBUD members.
- 3. All 4-H members are required to attend at least three (3) local 4-H club meetings (college

students must attend 2 meetings), participate in one county activity (such as 4-H workshops, 4-H week activities, other identified activities, etc.), and present a talk or demonstration on a 4-H project at their own club meeting in order to show projects at the Shelby County 4-H & Jr. Fair.

- 4. All members must have been enrolled in each project exhibited and be recorded in the Extension Office on or before April 1.
- 5. NO ENTRY FEE IS REQUIRED.
- 6. All exhibits must be the work of the individual making the exhibit for the current 4-H year. 4-H year is September 1 to August 31. One item may not be shown for more than one project area. 7. Entries due June 4. NO LATE ENTRIES!
- 8. All exhibits must be in place according to the schedule.
- Securely attach tag with name of exhibitor and the club to each item for all projects other than 9 livestock, horse/pony and dogs.
- 10. Premiums for all grades (except County projects) will be paid based on available funds.
- 11. The Extension Office will not be responsible for 4-H members' projects which are lost or stolen. 12. Decisions concerning protests and grievances will be the responsibility of the superintendent of
- the involved department and the County Extension Director. 13. All livestock exhibitors must have their entries in place by Sunday, July 18 at 8:00 p.m. No entries shall be removed until Wednesday, July 21 at 9:30 p.m.
- 14. 4 H Center and Produce Building exhibitors need to check their project area for their check-in time. Release will be on Wednesday, July 21 from 9-10 p.m and Thursday morning at 8 a.m.
- 15. Members failing to comply with rules and regulations will automatically forfeit their premium money.
- 16. Trophies will be awarded in classes that have sponsors.
- 17. Entries will be judged by the merit or group system. Exhibits in each class will be rated and placed in one of three groups:
 - A. Project met standards, Blue Award
 - B. Project needs some improvement, Red Award
 - C. Project needs much improvement, White Award
 - Ribbons or other suitable awards will be given to indicate the above placings.
- 18. As funds become available, premiums will be paid on the basis of the X factor, with 3X for Blue, 2X for Red, and 1X for White.

UNIVERSITY OF ILLINOIS EXTENSION **CODE OF CONDUCT FOR 4-H EVENTS & ACTIVITIES**

All participants in events and/or activities planned, conducted, and supervised by the University of Illinois Extension and 4-H, are responsible for their conduct to U of I Extension personnel and/or volunteers supervising the events. This responsibility is necessary for the health, safety, and welfare of the participants, and will be rigidly adhered to and uniformly enforced.

The following conduct is not allowed while participating in any 4-H event or activity and is subject to disciplinary action:

Category 1

- a) Possession, use, or distribution of alcohol and other drugs, including tobacco products. No vaping allowed.
- b) Theft or destruction of public or private property
- c) Involvement in sexual misconduct or harassment
- d) Possession or use of dangerous weapons or materials (including fireworks)
- e) Fighting or other acts of violence that endanger the safety of the participant or others

Category 2

- a) Willfully breaking curfew
- b) Unauthorized use of vehicles
- Leaving the site of the event c)
- Participation in gambling d)
- Absence from the planned program e)
- Intentionally interfering with or disrupting the event f)
- g) h) Use of profane or abusive language
- Disregard for public or personal property
- Public displays of affection or inappropriate actions i)
- Failure to comply with direction of Extension personnel, including designated adults acting i) within their duties and guidelines



Consequences:

The University of Illinois Extension reserves the right to restrict participation in future activities for those individuals who have been removed from an activity for behavior, as outlined in Category 1 or Category 2. In all cases, the participant will be responsible for restitution of any damages incurred by his/her actions.

Category 1:

- 1. When notified of any of the actions listed under Category 1, the adult in charge, will ascertain the relevant facts, and, with concurrence from the U of I Extension staff, will notify the affected participant of the action and any supporting evidence. The participant will be allowed an opportunity to answer the allegations and, if necessary, law enforcement officials will be notified. While facts are being verified, the participant will be removed from the 4-H activity/ event and be under direct supervision of an adult chaperon.
- 2. The parent or guardian will be notified of the actions of the participant, and upon finding the allegations to be true, must immediately remove the participant from the activity at the parent's or guardian's expense.
- 3. Documentation must be completed on an "Incident Report Form."

Category 2:

- 1. When notified of any of the actions listed under Category 2, the adult in charge, will ascertain the relevant facts, and, with concurrence from the U of I Extension staff, will notify the participant of the action and any supporting evidence. The participant will be allowed an opportunity to answer the allegations and, if necessary, law enforcement officials will be notified. While facts are being verified, the participant will be removed from the 4-H activity/ event and be under direct supervision of an adult chaperon.
- 2. The parent or guardian of the participants who violate curfew, use vehicles without authorization or leave the site of the event (as outlined in Category 2, letters a, b, c) will be notified of the actions by the participant. The parent or guardian must immediately remove the participant from the activity, at the parent's or guardian's expense. Participants who willfully disobey conduct as described in Category 2, letters d-I, will receive a verbal and written warning (initialed by the adult and the participant). Upon receiving a second warning, the parent or guardian will be notified of the behavior and must make arrangements for removal of the participant from the activity, at the parent's or guardian's expense.

Submitting 4-H fair entries indicates you have read the above and that you agree to the following: "We understand and accept the responsibility for following the "Code of Conduct" for this 4-H event or activity. We further understand that failure to do so will result in disciplinary action as outlined above and forfeiture of any participant's fees."

4-H MASTER SHOWMANSHIP

Wednesday, July 21

Judging will start at 1 p.m. or 30 minutes after the Beef Show. The Shelby County Master Showmanship winner is expected to participate at the Illinois State Fair Master showmanship contest to be held on August 13 at 7 p.m. The winner will need to find their own animals to compete at the state contest.

To qualify:

- 1. The 2021 Senior and Premiere Showmanship winners in beef, sheep and swine are automatically qualified to participate in the county contest. Exhibitors are not required to participate in the county Master Showmanship contest.
- 2. Exhibitors will need to pre-register with the Extension office by June 4. There will be a waiting list with the understanding that some of those who pre-register could automatically qualify by winning the Senior and/or Premiere contests in their species. There will be a maximum of 12 exhibitors.

Rules:

- 1. Exhibitor must exhibit at least one of the following species: beef, sheep, or swine at the Shelby County 4-H Fair.
- 2. Must be at least 14 years of age as of 9/1/20. (This is a state rule.)
- 3. It's your responsibility to find your own animals to compete in the county contest if you are not enrolled in that species. For example: You are a beef exhibitor but don't have sheep or swine, you must use your own beef and find a sheep and swine to borrow for the contest.
- 4. A special judge will be used for the Master Showmanship contest.

STATE FAIR REQUIREMENTS

General Projects showing at the Illinois State Fair

- 1. A 4-H'er must be 8 years of age by September 1, 2020 to be eligible to exhibit at the State Fair.
- 2. To be eligible for State Fair exhibition, the exhibit must have received an "A" rating.
- 3. Judges may select any number up to specified limits in different project areas, as determined by quality of projects.
- 4. Exhibitors must be present at the time of county judging to be selected as a State Fair Delegate.
- 5. State Fair Delegates must fill out the State Fair Delegate Form (dark purple) by Wednesday of the fair for their exhibit entry. Forms can be turned in at the 4-H Center, Fair Office, or the Extension office.
- 6. State Fair Alternates must fill out the State Fair Alternate Form (light purple) by Wednesday of the fair.
- 7. State Fair Alternates will be contacted for openings in State Fair Exhibits. Forms can be turned in at the 4-H Center, Fair Office, or the Extension office.
- 8. State Fair exhibitors may exhibit one general project at the State Fair.
- 9. All State Fair exhibitors will have the opportunity to experience conference judging during the Illinois State Fair.

Animals showing at the Illinois State Fair

- Beef, Dairy, Dairy Beef, Goats, Sheep, Swine, Rabbits, and Poultry are not shown on the same day as the other county projects. Any 4-H member meeting the State Fair requirements in the above projects listed in the Illinois State Fair Junior Department Premium Book can exhibit their animal at the State Fair and do not have to qualify at their county fair. Dogs must qualify during the dog show.
- 2. Illinois State Fair information can be accessed at the following website or by contacting the Extension Office. The county office must sign your entry form. *http://www.agr.state.il.us/isf/premium/junior.pdf.*
- 3. Completion of the Quality Assurance & Ethics Clinic (QAEC) is **required** for all State Fair exhibitors in the horse, rabbit, dog and poultry classes. 4-H and FFA members complete the Quality Assurance & Ethics Clinic online using this url: *http://web.extension.uiuc.edu/qaec/* by June 4.
- 4. Completion of the Youth For the Quality Care of Animals (YCQA) is **required** for all State Fair exhibitors in the beef, dairy, sheep, swine, and goat classes. 4-H members must complete a Face to Face training or Online training by June 4.

Horses showing at the Illinois State Fair

- Copies of the ownership and/or lease papers and one set of the photos for horse/ponies exhibiting at the State Fair must be on file with the Shelby County Extension Office by May 1, 2021. Any number of pictures with ownership/lease papers may be turned in by the <u>May 1</u> <u>deadline</u>. No 4-H'er may show more than three (3) horse/pony combinations.
- 2. State Fair entry forms are due into the Shelby County Extension Office at a date to be determined.
- 3. No replacement animals will be allowed in the State Fair Junior Horse Show unless that animal has already been registered in the Extension Office by the <u>May 1 deadline</u>. Replacement animals may be allowed only with a vet certificate and if the exhibitor has pictures on file with the Extension Office. The replacement horse may only be exhibited for the same classes as the horse being replaced was signed up for.
- 4. Violations of the ownership/leasing rules will not be tolerated. Violations may result in disqualification from current and/or the following year's State Junior Horse Show and forfeiture of all premiums and awards.

- 2. All livestock exhibitors must have their entries in place by Sunday, July 18, at 8:00 p.m. No entries shall be removed until Wednesday, July 21 at 9:30 p.m. Any exhibitor failing to comply with the above rules will forfeit their premiums won during the fair.
- 3. No artificial coloring will be allowed in livestock classes.
- 4. All animals exhibited in showmanship classes must be owned and cared for by the exhibitor. All animals will be exhibited in the Show Ring by 4-H'ers.
- 5. All livestock must comply with "Illinois Exhibition Livestock Health Requirements." See information in the front of this book.
- 6. Three (3) showmanship classes will be offered in the Beef and Swine divisions. Age groups will be split 8-11, 12-14, 15-19 years of age. The winner of each age group will be eligible to show in the next higher age bracket the following year. Inclusion in age brackets will be based on the 4-H'er's age as of September 1, 2020. 4-H'ers may win each division only one time except for premiere.
- 7. Two (2) showmanship classes will be offered in the rabbit, poultry, goat, sheep, and dairy divisions. These classes will be divided 12 years and younger and 13 years and older. Junior class winners are eligible to compete in the Senior division the following year. Exhibitors may win the Junior and Senior showmanship classes only one time. Inclusion in age brackets will be based on the 4-H'er's age as of September 1, 2020.
- 8. Two (2) showmanship classes will be offered in Horse and Ponies. One class will be for Junior exhibitors 13 and under as of September 1, 2020; the other for Senior exhibitors, 14 and over. The top 2 places in each class will compete for champion. The first place winner that is not chosen champion will compete against the second place winner from the division the champion was in for the reserve championship. Exhibitors may win the Champion Showmanship Class more than once.
- 9. <u>PREMIERE SHOWMAN AWARD</u> The Premiere Showman Award is open to current and <u>all past</u> Senior Winners and <u>all past</u> Premiere Winners in the Beef, Swine, Goat, Sheep, Dairy, Dairy Beef, Rabbit and Poultry departments that are still eligible for 4-H. Ribbons will be presented to Grand and Reserve Grand Champion Premiere Showmen. <u>This year's winner will be eligible for next year's contest</u>.

Excess adhesive on the legs beyond what is needed to groom the animal's hair is grounds for disgualification.

- Each exhibitor <u>must</u> have on file by <u>May 1</u> at the Extension Office a copy of ownership/lease papers for animals exhibited in the Shelby County 4-H Fair Horse Show or at the State 4-H Horse Show, with 2 photos (one of each side of animal). *** <u>No horse or pony may be shown in the</u> <u>Junior Fair Horse Show without the required photos that are due to the Extension Office by May</u> <u>1, 2021.</u>
- 10. Any number of pictures with ownership/lease may be turned in by the <u>May 1</u> deadline.
- 11. No exhibitor may show more than three (3) horse/pony combinations.
- 12. No replacement animals will be allowed in the Show unless that animal has already been registered in the local Extension Office by the <u>May 1</u> deadline.
- 13. Replacement animals may be allowed only with a vet certificate and if the 4-H'er has pictures on file with the Extension Office. The replacement horse may only be exhibited in the same classes as the horse it is replacing. The only substitution would be mare and gelding halter classes and between the horse and pony classes.

Example: If you were signed up for all the pony classes, provide a vet certificate that the pony is unable to be shown and have a back-up horse's picture on file, you then could substitute the horse into the same horse classes that the pony was signed up.

- 15. - Cloverbud MUST present a talk or demonstration at a club meeting (NOT on a farm tour);
- Cloverbud MUST participate in a county activity.

Exhibiting at the fair:

- Cloverbuds may bring up to two projects to display.
- Cloverbud members **may not** receive premium money.
- Cloverbud participation ribbons will be awarded.
- Cloverbud members may make projects related to Cloverbud project areas. Those projects will be displayed in the 4-H Center.

State 4-H Rule—Livestock Projects

- Per the State 4-H Office, Cloverbud members **MAY NOT** exhibit any type of animal projects.
- Members may make a poster that includes pictures and information about their animal. The poster will be displayed in the 4-H Center.

Cloverbud projects should be in place in the 4-H Center between 4-8:00 p.m. Sunday, July 18. Projects will be released between 9:00-10:00 p.m. Wednesday, July 21 or Thursday, July 22 between 8-8:30 a.m.

Chit Chat with a Cloverbud will take place on Wednesday, July 21 at 10 a.m. in the 4-H Center. This isn't an actual judging event, but an opportunity for Cloverbuds to experience conference judging to prepare them for their first year in 4-H. Attendance is not mandatory.



Clarifications for 4-H General Projects for 2021

Choose whatever method best shows what you've learned. The 4-H'er must furnish any equipment needed for the exhibit. Internet service will not be provided for the exhibit. All exhibits must include something visual, such as a printed copy of a digital presentation, which will remain on display during the exhibition. Electronic equipment will only be used during your personal judging time and will not remain on display during the entire exhibit period.

Ready4Life Challenge

Exhibits in this category must include the following:

- Must be enrolled in the specific Ready4Life project to exhibit:
- Must be 11 years by September 1, 2020 or older.
- A physical representation of the career or business product such as a model, prototype or display/portfolio that includes images of accomplished work.
- Verbal or written explanations that demonstrate knowledge of the related career or business fields, potential careers, and the appropriate requirements for achievement in those fields.
- The judging criteria for this class values thoroughness of career and/or business exploration and pursuit above the workmanship of the physical specimen on display.

Maker

NOTE— This class will be exhibited on Wednesday, July 21 at 1:00 p.m. with check in from 4-8 p.m. on Sunday evening in the 4-H

Center. Exhibits in this category are designed to be multi-disciplinary in nature, innovative, and must not fit into any other exhibit category. To qualify for this category, your project MUST abide by the following guidelines:

- Exhibitors must complete the DIY Make & Build Curriculum, and answer all the questions at the end of each lesson. You must display (or upload if virtual) your answers to these questions, as well as your Maker Log from the DIY Make and Build curriculum.
- Exhibits must be an object or device that has an intended purpose and uses technology in either a mechanical way, digital (computer) way, or combination of the two. Your device or object **cannot** be one of the included activities in the DIY Make and Build Curriculum.
- The device must be something that can be used in everyday life by multiple people (a target audience), and MUST be manufactured/built by the exhibitor (If not fully manufactured by the exhibitor, the device MUST be modified structurally or be reprogramed to perform a different function other than what it was designed to do).
- Exhibits MUST be able to interact with the outside world. (e.g. an on off switch, input sensors, feedback, etc.)
- Exhibits MUST include a detailed build log with instructions on how to make or build the exhibit, AND contain either a 3D rendering or detailed and labeled sketches of the device/ product.
- All parts and software used in the design/build MUST be listed in a detailed Bill of Materials including cost per item and total cost. Total time spent on the build must be documented in your build log.

In addition, exhibitors are HIGHLY encouraged to use tools such as 3-D printers, laser cutters, routers and/or other hand/power tools to help in the manufacturing process (NOTE: Simply 3-D printing or laser cutting an object without the other specifications does not qualify as a Maker Project). It is also HIGHLY encouraged that exhibits use Open Source software and/ or hardware in the build.

Note: There are innovation classes added in some of the General Projects. An exhibitor may bring only a class project or innovation project, but NOT BOTH.

Bicycles may not be ridden on the Fairgrounds, except when performing in the classes. **Bicycle riders must bring and wear safety helmets during the riding exercises.** Each exhibitor will be given a written or oral test on proper maintenance, adjustment, operation, bicycle parts, and safety rules regarding bicycles; inspection of exhibitor's bicycle, including brakes, height, safety equipment, etc.; and riding "test" through a safety course, observing all rules and regulations.

- Bicycle Level 1 *Not Eligible for State Fair* Exhibitors will draw three situations from a bag that relate to activities from Level 1 and discuss/explain all three with the judge. Situations may include: Selecting bicycle safety equipment; Demonstrate how to fit a helmet; Identify bike parts and their function; Selecting the right size bike; How to check bicycle tires, brakes and chains; Recognizing traffic signs and their meaning; General discussion of bicycling hazards; and Items to consider when planning a bike trip.

Judging - Wednesday, July 21

Judging will start at 1:00 p.m., Shopping in Style 2:00 p.m. Exhibits must be checked in between 4:00-8:00 p.m., Sunday, July 18 4-H'er must be present for judging. Exhibitor limited to one entry per project area.

All exhibits entered in the clothing and textiles area will be judged based on their construction and fit (if applicable). Exhibitors bringing garments should not wear their garments when they arrive for judging. The garment will be reviewed by the judges for construction first. Exhibitors will be asked to change into the garment as the second step of the judging process. If the garment was constructed for another individual, that individual must be present to wear the garment for the judge. (Only the exhibitor who made the garment is eligible for ribbon and premium.) Construction and appearance will both be considered during judging. If a pattern was used to make the item, the pattern instructions, either written or electronic, are to be included with the exhibit. Exhibit tags should be attached to the garment, not to the hanger.

Members wishing to exhibit knitted items should enroll in Visual Arts Fiber (if original) or Heritage Arts (if made from a pattern). Members who enroll in Clothing & Textiles with the intent of pursuing quilting can exhibit in the non-clothing exhibit category in STEAM Clothing 1—FUNdamentals. Quilts exhibited in the Clothing & Textiles area will be judged using a rubric that evaluates the sewing skills and construction of the item. All work on the quilt MUST be completed by the 4-H member. You cannot exhibit a quilt that was quilted by someone else. Quilts can be hand OR machine quilted as long as ALL work is completed by the exhibitor.

Garment/items will not be placed on display unless covered in a clear plastic bag (no garment bags). Exhibit tags should be attached to the GARMENT, not to the hanger.

All three blooms or stems should be the same variety, color, shape and size and must have been grown from seed, young seedling plants, bulbs or rhizomes by the exhibitor. (NOTE: Exhibitors choosing lilies should include no more than 2/3 of foliage for their exhibit.)
- 50193------ Floriculture B Exhibit one of the following options:
 - Display a mixed planter that may include herbs with foliage plants and/or flowering plants. The planter should include three or more kinds of plants. The container exhibit space must not exceed 18"x18".
 - Create an artistic display of dried flowers and/or herbs explaining how each was dried; OR
 - Create a photo collage or collection of pictures of plants from your theme garden. Label your plants by name and explain how the plants were chosen to fit the theme.

 - Create a terrarium. Selected plants should be started by the exhibitor from cuttings or seeds or as purchased plugs. The terrarium must be cared for by the exhibitor for at least 5 months.  - Exhibit a plant that you propagated from cuttings, layering or division or started from seed. Create a photo board showing the progression of growth. 50195------ Floriculture D – Create an exhibit of forced bulbs in a pot.

50196------ Floriculture Display: (Open to youth enrolled in Floriculture A, B, C, and D) Present an exhibit of the member's choice that focuses on some aspect of floriculture which does not fit in the categories above. The exhibit may include, but isn't limited to, dish gardens, original works, objects, demonstrations, digital presentations, programs, websites, games, apps, performances, or posters which you have made.

Exhibit must be in place by 9:00 a.m. on Tuesday in the 4-H Center.

4-H'er must be present for judging.

Exhibitor limited to one entry per project category (may only show in Cooking 101, Cooking 201, etc. but not more than one category)

ALL food entries must be displayed on a disposable plate and placed in a zip-sealing plastic bag. <u>All entries must include recipe and menu</u>. Recipes and menus may be hand written or typed on note cards or a piece of paper. <u>Shared cakes, breads, etc. will be disqualified</u> at the judges' discretion, and no premium will be paid to either exhibitor.

New for 2021—4-H'ers may exhibit one of each exhibit opportunity listed. Example in Cooking 101 - may exhibit 3 cereal bars, 1/4 of a coffeecake and 3 cookies.

<u>Note- No Jr. Fair foods will be allowed to be</u> <u>exhibited in the 4-H foods projects.</u>

- Prepare an exhibit of 3 cereal marshmallow bars OR

No icing should be on any products. If you make changes to the recipe, bring a copy of the recipe with your changes. Bars, coffeecake, or cookies should be displayed on a disposable plate placed in a zip-sealing plastic bag. *In addition to your food exhibit*, complete the *What's on Your Plate? Activity* on pages 10-11 in the 4-H Cooking 101 project manual. Bring a document with printed pictures of your 3 or more plates and the answers to questions 1-7 to remain on display with your project. The words on the plates must be legible and clearly visible in the picture. Pictures, graphics or photos are acceptable

- 50206------- **Sports Nutrition:** Prepare a display, digital presentation, or poster on one of the activity chapters in the manual that you completed. The activity chapters are listed by page number in the table of contents. Your exhibit should include, at minimum, information on one physical fitness component and one food/recipe component from the activity chapter. The exhibit should include the project manual with the pages of the activity completed. You may also include live demonstration of physical activities. Do not bring food made using the recipes, but consider adding pictures of the completed recipes to your exhibit. You must furnish any equipment you need for the exhibit. Examples for Activity 1

Example A: Make a video of yourself practicing flexibility, strength and endurance physical fitness activities and making pasta salad with different vegetable, pasta and dressing ideas. Bring a screen shot and brief description of your video to leave on display.

Example B: Make a poster of pictures of flexibility, strength and endurance physical fitness activities and information on the results of making the spinach and mandarin orange salad. Include answers to the questions in the book.

50208------ **Food Preservation:** Prepare an exhibit using ONE of the following food preservation methods: canning; freezing; drying; pickles/relishes; jams, jellies and preserves **OR** a combination of these (see Preservation Combination option below),



excluding Freezing. <u>No freezer jam exhibits will be allowed for Freezing; Jams, Jellies,</u> and Preserves; or for the Preservation Combination options.

Canning – The exhibit should include two different canned foods in appropriate jars for the products. Food may be fruit, vegetable, or tomato product (i.e. salsa, juice, etc.).

Freezing – Prepare a nutrition display that illustrates a freezing principle. There is NOT a food exhibit option for this preservation method.

Drying – Exhibit two (2) different dried foods packed in plastic food storage bags. Choose from fruit, vegetable, fruit leather or meat jerky.

Pickles and Relishes – Exhibit two pint jars of different recipes of pickles and/or relishes.

Jams, Jellies, and Preserves – Exhibit half-pint jars of two different jams, jellies, and/or preserves.

Preservation Combination – Exhibit two different preserved food products, excluding Freezing, in appropriate jars/packaging (drying). For example, exhibit 1 jar of tomatoes (Canning) and 1 half-pint of jelly (Jams, Jellies, and Preserves).

All preserved products should be prepared and processed according to the current USDA/ Extension information. USDA information on preserving food, including recipes, can be found at: <u>www.homefoodpreservation.com</u> or <u>web.extension.illinois.edu/foodpreservation/</u> Recipes must be processed in a water-bath or pressure canner.

<u>All food exhibits must be labeled with:</u> 1) The name of the food; 2) The date preserved; 3) Appropriate method(s) of food preservation (For canned projects: boiling water bath or pressure canner; For drying projects: Specify equipment used (food dehydrator, oven, etc.))

Examples:

Strawberry jam, boiling water bath. July 13, 2021. Green beans, pressure canner. July 13, 2021 Beef jerky, food dehydrator and oven. July 13, 2021.

<u>All food exhibits must be accompanied with the recipe(s)</u> – typed or written, with the source of the recipe(s) listed. <u>Required Recipes and Sources for Food Preservation Exhibits</u> – all food preservation recipes be from an approved source. Those sources are:

- PUT IT UP! Food Preservation for Youth manuals
- U.S. Department of Agriculture (USDA)
- National Center for Home Food Preservation
- Ball/Kerr Canning (recipes after 1985)
- Mrs. Wages

• DO NOT BRING RECIPES FROM: Magazine or newspaper clippings, Pinterest (unless it is from a source listed above), Grandma's or a recipe from a family member or friend without a source, Cookbooks (excluding the Ball, Kerr and Put It Up! book).

Canning Equipment Requirements: All canned products must be canned in clear, standard jars in good condition (no chips or cracks). Jars must be sealed using two-piece canning lids (flat lid and band). Must use a new, unused flat lid. Bands must not be rusty or severely worn.

- 50218------ **Pebble Pups 1** Display 8 to 19 rocks and mineral specimens with three minerals in the collections. Collection may include duplications that show variations. Label collection and note where found.

ALL photos must be accompanied by details of the camera settings that include:

- Camera/device used
- Aperture (F-stop)
- Exposure time (shutter speed)
- ISO (film/sensor sensitivity)
- Lighting used (flash, artificial, sunlight, other)
- Lens Filters (Ultra-Violet, Polarizing, etc) if used.

Members are allowed to shoot on a camera's automatic setting, but should be able to find the metadata information on the photo to discuss the information above.

Additional details required for Photo Editing ONLY:

- Photo editing software/application used (required for ALL edits and retouches except for cropping)
- Filters used (lens filters and or digital/software filters)

The exhibition size requirements for all photographs will be: Minimum image size: 5X7 Maximum image size: 8X10 Maximum exhibit size (including frame): 18X20

All exhibitors must include unframed (taped to the back of the framed exhibit or attached to the project booklet) **original or un-edited** versions of either the same subject or the examples of the same technique that the framed image represents. This will assist the judge in understanding the choices made by the photographer to build the exhibited composition.

Formal Speeches share the presenter's own unique view and are intended to motivate, persuade, or inform an audience and may include a call to action. Youth deliver a speech on any topic they wish.

Illustrated Speech | Self-written | Notes Allowed | Illustrations Required | Individual | 4-6 minutes

Illustrated Speeches may be used to inform, persuade, or motivate the audience while using a visual aid. Visual aids may be two dimensional, three-dimensional, or digital. Youth may include audience participation. Digital visual aids must be stored on a USB flash drive. Illustrated speeches may be:

- How-to demonstrations which show the audience how to do something.
- Object lessons which use objects as metaphors to share a message.
- Educational models where drawings or diagrams help explain a topic.

Original Works | Self-written | Notes Allowed | Props and Costumes Allowed | Individual or 2-Person Team | Manuscripts sent in Advance | 4-6 minutes

Original works must be written entirely by the presenter. It may be presented as an individual or a two-person team entry. Manuscripts must be sent in advance to the contest. Judging will start at 1:00 p.m. Exhibits must be checked in between 4:00-8:00 p.m., Sunday, July 18 4-H'er must be present for judging. Exhibitor limited to one entry.

Enrollment in the Video project is required to exhibit in the classes in this section. Entries in 360° video may be enrolled in video/film or computer science projects.

All Exhibitors must bring their video to be judged on a USB flash drive and saved in .MP4 format. Exhibitors are encouraged to post their video on YouTube.com in advance of State Fair. Exhibitors may choose whether to make the video "public, unlisted" (someone must have the link to view it), or "private" (only people you choose may view it). This will allow fairgoers to view the exhibits on display. There will be monitors at the exhibit table for viewing videos so exhibitors will NOT need to bring a laptop or device for viewing.

Requirements that apply to ALL video classes:

Video submissions should be no longer than five (5) minutes in length (unless noted differently in class description.). Videos are to be original and a result of the member's current year's work. Criteria for judging shall include: (1) Evidence of story line; (2) Use of camera angles; (3) Use of zooming techniques; and (4) Smoothness of scene changes. Image and sound quality will be considered in relation to equipment available to and used by exhibitor. All videos should comply with copyright regulations and display an image that is appropriate for 4-H audiences. No time or date should be imprinted on the video footage. All videos should include an opening title screen, as well as closing credits which include date of production, name of video exhibitor and research sources if appropriate. All Video/Filmmaking exhibitors must include a printed copy of materials which will remain on display.

4-H VISUAL ARTS

Judging – Tuesday, July 20 See project area for judging time. Exhibits must be checked in between 4:00-8:00 p.m., Sunday, July 18 4-H'er must be present for judging. Exhibitor limited to one entry per class.

ALL projects must have been checked in with superintendent by 9:00 a.m. on Tuesday. The Superintendent will have your exhibitor tags.

Exhibitors must be enrolled in the Visual Arts project category in which they are exhibiting. Articles must have been made **during the current 4**-**H year** which started September 1, 2020. Exhibitors are encouraged to date the project when it is made. All visual arts exhibits are evaluated using a visual arts rubric which takes into account correct use of design elements; craftsmanship; and creativity.

Articles exhibited must be an original design created by the exhibitor (except in heritage arts which may follow a pattern AND Fiber-Non Original Ages 8-10 ONLY). Copyrighted or trademarked designs are not acceptable; this includes Team or School logos. Kits and preformed molds are not considered original and are not acceptable in any Visual Arts Class. Combining parts of different patterns (pictures, photographs, images from the internet or a magazine) with the member's own ideas can result in an original design, but simply changing the color, pattern and/or size of a pattern does NOT make the design original. This also applies for ideas found on a site such as Pinterest. If you see something on Pinterest that you like, use the concept and create something different using the concept; however it MUST NOT look exactly like something the judge can search for and find on Pinterest. The exhibit must combine parts of different patterns and/or ideas with the concepts of the member, however changing the color or changing the size of the item or pattern used does NOT make it original. If you create a replica of what you see somewhere else, it is not your original design. If a photo, sketch, or other idea source was used, submit it with your entry, firmly attached to your exhibit. Be prepared to explain how and where you found the idea for this project.

Members wishing to exhibit quilts made from a pattern may enter it in Heritage Arts. Quilts exhibited in the Visual Arts – Heritage Arts area will be evaluated using a visual arts rubric which takes into account correct use of design elements; craftsmanship; and creativity. All work on the quilt MUST be completed by the 4-H member. You cannot exhibit a quilt that was quilted by someone else.

All items must be properly prepared for exhibit. Items which are intended to be hung must be prepared for hanging. The hanging device must be sturdy enough to support the weight of the object. Framed items not intended to be hung should be noted as such on the exhibit tag and a photo of the artwork being displayed should be included.

Exhibit a single layer decorated cake, using a minimum of four different techniques. Exhibit may use cake OR cake form.

50336-Division A: Canvas, Paper, Glass:

Any original art work done with pencils, chalk, pens, ink, paint, charcoal, dyes, etc. on canvas, paper, or glass. This would include all painting, sketching, drawing, cartooning, original non-computer generated graphics, printing, etc. Painted and/or glazed pre-formed ceramics and painted porcelain dolls are not eligible for State Fair exhibit. Drawings and paintings should be matted or framed under glass. (Exceptions: Oil and acrylic paintings do not require glass and are not required to be matted.) Water color, chalk, pen & ink, computer-generated art, etc. do require some protective covering. Gallery frames are acceptable. Canvas paintings that continue "over the edges" are acceptable without frames; however, the piece must still be prepared for hanging. Matted pieces without frames are acceptable, however the piece must be prepared for hanging OR it must include a photo of the artwork being displayed in a non-hanging manner. There is no specific requirement for the type of mat used.

50352-Division B: Wood, Metal, Textiles:

Any original art work done with pencils, chalk, pens, ink, paint, charcoal, dyes, etc., on wood, metal, or textiles. Painted and/or glazed pre-formed ceramics and painted porcelain dolls are not eligible for State Fair exhibit. Any exhibits created as a piece of wall art must be prepared for hanging.

Judging time is 1:45 p.m.

Judging time is 2:00 p.m.

50338 ------- Visual Arts Computer-Generated Art: Any original art created in any software package. Exhibit may not include scanned work, clip art, downloaded images from the internet, any imported image, or photographs. All pixels must be original. Photo mosaics are NOT allowed. Exhibitors in this class (like all other classes in this sub-section) must be enrolled in Visual Arts; Computer project enrollment is not required. <u>NOTE:</u> Wood and metal exhibits created through the use of laser cutting programs/devices should be entered in this class. Plastic exhibits with an artistic focus created using a 3-D printer should be entered in this class. If the art created is designed to hang, then the entry should have some protective covering, such as a glass frame, and prepared for hanging. If the art is something that has been created with a laser cutting program/device and is NOT designed to hand, it does not require protective covering nor does it need to be prepared to hang.

50339 ------- Visual Arts Fiber: Any <u>original item</u> made of fiber. Examples are quilts, fabric collage, soft sculpture, stitchery, weaving, embroidery, cross-stitch, wearable art, hooking, braiding, duct tape artistry, string art, and baskets. Original cross-stitched, knitted, crocheted or quilted items belong in this Fiber class. Nonoriginal cross-stitched, knitted, crocheted or quilted items should be entered in Heritage Arts. Machine knitted items are not appropriate for this class.



50350 ------ Visual Arts Fiber Non-Original AGES 8-10 ONLY: Any non-original item made of fiber. Examples are fabric collage, soft sculpture, stitchery, weaving, embroidery, cross-stitch, crocheting, knitting, weaving, hooking, and felting. Exhibitors may use a pattern and/or an idea generated from another source.

Judging time is 2:00 p.m.

50340 ------ Visual Arts Glass/Plastic: Any original item made of glass or plastic. Possible items to exhibit include stained glass, etched glass (original design), mosaics made of glass, glass beading, plastic jewelry (friendly plastic). Interlocking building block creations (i.e. LEGOS) are not suitable for entry. Stepping stones or wall hangings that include cement decorated with glass or plastic items are not suitable for this class.

Judging time is 2:30 p.m.

50341 ------ Visual Arts Heritage Arts: Exhibit an item of *traditional* art learned from another person or from a pattern (NO KITS) may be entered in this class. Nonoriginal cross-stitched, knitted and crocheted items by pattern fit in this class. ALL ORIGINAL cross-stitched, knitted and crocheted items should be exhibited in Fiber Arts; (machine knitted items ARE NOT acceptable for this class.) Other possibilities include: needlepoint, counted cross-stitch, crewel, embroidery, cut work, hardanger embroidery (embroidery openwork), macramé, baskets, candles, pysanki (decorated eggs), leather, quilts, baskets (made using a traditional pattern), traditional handmade dolls with handmade costumes, soaps made using nature dyes also can be made using hand-made molds or broken into chunks for display, or candles. OR Leather Carving or Tooling: Exhibit should use simple swivel knife tooling techniques or may incorporate several swivel knife-tooling designs or patterns – exhibit examples include items such as belt; pictorial carving; key case.

OR Leather Lacing: Exhibit to include stamping and/or carving techniques incorporated with lacing techniques – exhibit examples include items such as wallets; purses; etc. **OR**

Leather Stitching: Exhibit may include stamping; carving and/or lacing techniques and should be a leather item or article of apparel, which incorporates hand-sewing and/or machine stitching techniques. Hand-sewing and/or machine stitching must be the work of the exhibitor.

50342 ------ Visual Arts Metal: Any original item made of metal such as sculpture, tin punch, engraved metal, and jewelry. Items intended for industrial use (as tools and/or shop items) are not considered part of this Visual Arts project and are not eligible for entry. Metal items that have been partially or totally created through the use of laser cutting programs/devices should be entered in Computer-Generated Art.

50343 ------- Visual Arts Nature: Any original item made of natural material such as wreaths, cornhusk dolls, etc. Items should be made of natural materials (which may be purchased) but securing elements such as glue and wire may be used in the inner construction as long as they do not detract from the overall "natural" appearance. Articles such as dried pressed flowers may be displayed under glass since it is necessary for protection/preservation of the natural materials. Candles are not suitable as entries. "Embellishments" are defined as the decorations or special details and features that add to a page and make it more visually appealing. Embellishments may include, but are not limited to, ribbon, clips, special lettering, etc. Intermediate level exhibitors must use a minimum of eight embellishments and tell a story with pictures and journaling.
- 50347------ Visual Arts Scrapbooking, Advanced: Exhibit one album or notebook, either $8 \frac{1}{2}$ " x 11" or 12"x12", with a front and back cover. The album/notebook must have a minimum of 4 pages (front and back, 8 sides), exhibited in page protectors. "Embellishments" are defined as the decorations or special details and features that add to a page and make it more visually appealing. Embellishments may include, but are not limited to, ribbon, clips, special lettering, etc. Advance level exhibitors must use a minimum of 12 embellishments and tell a compelling story with pictures, journaling, and other media.

Originality and design are important concepts. Craft and preformed or assembled projects are not acceptable.

Shelby County 4-H Ribbons

A Rating - An A rating ribbon is a blue ribbon with a 4-H clover on it. This ribbon means that the project met the project standards.

B Rating - A **B** rating ribbon is a red ribbon with a 4-H clover on it. This ribbon means that the project needs some improvement.

C Rating - A C rating ribbon is a white ribbon with a 4-H clover on it. This ribbon means that the project needs much improvement.

State Fair - A State Fair ribbon is purple and means the project has been selected to go to the IL State Fair.

State Fair Alternate- A State Fair alternate ribbon is lavender and means the project has been selected to go to the IL State Fair if the State Fair winner chooses not take his/her project.

Top Project - The judge thought the project was very well done and deserved extra recognition.

Champion - A 4-H Champion ribbon will have a 4-H Clover on the rosette and is purple. The project was chosen as the best 4-H project in that project area.

Reserve Champion - A 4-H Reserve Champion ribbon will have a 4-H Clover on the rosette and is lavender. The project was chosen as the runner up 4-H project in that project area.

Champion and Reserve Showmanship - Champion and Reserve Champion Showmanship ribbons are presented to the winners and runner-ups in each age division in the livestock, rabbits, poultry and horse shows. Showmanship classes are based on the 4-H'er and how they exhibit their animal, knowledge of their animal, and overall presentation.
