Walk a mile in their shoes...

On October 29, 41 Windsor school district staff and city council members participated in a Poverty Simulation held by the University of Illinois Extension. The simulation was organized and facilitated by U of I Extension Unit #19 staff and CED Extension Specialist Nancy Esarey Ouedragoo, Susan Ogwal from the Lieutenant Governor's office and Extension staff from Unit #26 and 20 also assisted. Participants were assigned roles to play as community members who were experiencing poverty and felt the challenges of living with limited resources and an abundance of stress. For one "month" (four, 15-minute weeks) they were tasked to secure food and shelter while maintaining the family and negotiating support systems, agencies, and the real world. Participants then went through a debriefing of their experiences, sharing what they discovered were real challenges for this population and brainstorming ways they could be more helpful in their real-life roles. There were many insightful observations made that day that will assist them in working with low-income students and families. U of I Extension Unit #19 SNAP-Ed staff have been working with the schools to provide programming, special events and food distributions and will continue to provide these services.

He gave some great information on what current scams were happening, how to protect yourself and what to do if you find yourself a victim. He emphasized that if anyone finds themselves a victim of scams or fraud, to not be embarrassed and hide it, but to report it and tell others so they can be aware and protect themselves.

PAHCE is an educational and service-oriented group that has been closely affiliated with U of I Extension for many years and includes members from Moultrie, Douglas and Coles counties. Cumberland County also has a group that is quite active as well.
