Livestock Possession Deadlines

The following dates are the 4-H possession deadlines for livestock projects:

January 1

Beef & Dairy Cows, Goats-Milking Does & Meat Does

February 1

Market Beef Steers & Heifers
May 1

Horses and Ponies, Bucket Calves, Beef or Dairy Calf, Market and Breeding Sheep, Dairy Heifers, Goats all other

June 1

Breeding Beef Heifers, Swine -Gilts and Barrows, Poultry, Rabbits

4-H'ers must be enrolled in the appropriate project no later than April 15 and have their animals in their own possession by the deadlines listed above. If all goes well 4-H Livestock Fair August 6-8, 2021 Sandwich Fairgrounds

Beef Weigh-Ins

Individuals wishing to participate in the Illinois State Fair with a steer exhibit (Premiere program or otherwise) or in the DeKalb County 4-H Beef Efficiency program should mark their calendars for **Saturday, February 6 from 10:00 to 12:00 PM** for their cattle to be weighed and tattooed. Tattooing and weigh-in procedures will be conducted at Larson's Farm, which is located at 17520 Keslinger Rd., Maple Park. We will be working in the processing barn at this location.

This will be the only day available for steers to be weighed and tattooed for either the State Fair or the county Beef Efficiency program...so please make arrangements to attend.

Important information for 4-H'ers taking an animal project

For members enrolled in dairy cattle, beef cattle, swine, sheep, and goat projects:

The YQCA is a livestock quality assurance program that replaced PQA. All 4-H exhibitors of these animals will be required to certify in the YQCA program each year. At this time, certification is done on-line via the website **http://yqca.org**. The YQCA program is for youth ages 8-21. The online version is broken into age divisions as follows: juniors 8-11, intermediate 12-14, senior 15-18, and young adults 19-21. This certification is needed each year with test out options of 1-3 years. Youth exhibiting swine at the Illinois State Fair and 4-H fairs are no longer required to be PQA plus certified. The estimated cost is \$12.

For members enrolled in horses, rabbits, poultry, dogs, and cats:

The Quality Assurance and Ethics training is required for youth in horses, rabbits, poultry, dogs and cats. You only need to take it once in your lifetime. Those who don't complete the training will be removed from the animal science project and will not be eligible to exhibit at county fairs. The website is open year round @ http://web.extension.illinois.edu/qaec/. NOTE: Youth must be logged on to a computer for this program, either a desktop or laptop; not an iPad or iPhone.

Beef Efficiency

Once again this year, the Cattlemen's Association will allow 4-H members to use their own steers in the Beef Efficiency Contest. By using your own steer you can show it in both the efficiency class and the regular beef class at the 4-H Fair. Steers will be weighed in February 6 with the state fair weigh-in. The contest is based on rate of gain, record book, ultrasound and the live class placings. Premiums are paid in each of these areas and, the overall winner receives a monetary award of \$200. Contact the Farm Bureau for an enrollment form.

Bucket Calf

The Bucket Calf Class is a great opportunity to raise a small calf. The Bucket Calf Class is open to members 8 to 13 years and includes raising a small calf, keeping records and showing it at the Fair. Calves need to be born between Feb. 1 and April 1, 2021. NOW is the time to enroll in the Bucket Calf Class by obtaining a form from the Farm Bureau office. Please return the form to the Farm Bureau office by Feb. 1 in order to show in the Bucket Calf Class at the 4-H Fair. Record books will be distributed at an informational meeting in February.
