SPONSOR: Kendall County 4-H Teen Federation

COST TO ENTER THE SKATING RINK: \$10 is the price for the two hours skating that includes the games played on the rink, and skates and Credit Cards or Cash will be accepted as payment at the door. Only approved enrolled 4-H members, and their families, will be able to skate. You can bring your own in-line or roller skates from home if you have them. The cost for anyone to skate is \$6 *at the door*, with \$4 extra for the skates. Chaperone's not skating can watch for free.

CHARITY DONATIONS FOR SKATERS:

Illini Fighting Hunger is the charity 4-H Teen Federation has chosen this year. Each 4-H skating youth (age 8 and up) is responsible for collecting at least \$10 in pledges, with checks made out to **Kendall County 4-H Foundation**. Pledges are flat donations.

PRIZES:

We will give a Prize for the person who collects the most pledge money for this Charity event. There will be a goody bag (we accept donations by Feb. 11) for each 4-H member that has turned in a permission slip, skates, and brings in their donations for Illini Fighting Hunger.

YOUTH REGISTRATION:

Skating youth must give the signed permission slip to their club leaders by the date their leaders set, so the leader can have a complete list to the office by **Feb. 11**. Cloverbuds or non 4-H family members, like parents or siblings, will need to be listed on the permission sheet, so we know how many are coming. This will insure that we and have enough help at the rink and enough goody bags.

Skating youth can bring sponsor sheets with their money to the registration table at check-in on the day of the Skate for Charity event, so we can award the youth their prize for collecting the most money. If charity donations are not turned in the day of the skating event, participants need to turn in money to the Extension Office by Monday, **March 2**, or bring it to the leaders meeting that same day. Those who sign up to skate are agreeing to collect a charity donation of at least \$10.

Since this 4-H community service event is for 4-H members and their families only, you need to be *approved* in the 4honline.com system, meaning you must have the correct *risk form* turned in along with your *4-H program fee paid* in time to have office staff approve members. December 1 is the enrollment date.

Skating will start as youth and families arrive at the skating rink and run 5-7 pm.
