

Henderson County Absentee Rules for 4-H General Project Show (As stated in the 2022 4-H Fair Book)

4-H members are required to be with their exhibits for conference judging unless Absentee Exhibitor Rules are followed. If the 4-H member is not present for judging and an **Absentee Exhibitor Form** is not attached to the exhibit, the exhibit will not be judged and is not eligible to receive an award or premium.

12. Absentee Exhibitor Rules:

- a. If you are unable to attend the 4-H General Project Show you must fill out an Absentee Excuse Form ahead of time, stating a valid reason for not being present. The exhibitor, a parent/guardian, and the exhibitor's 4-H leader must sign this form. Completed forms **MUST** be in the Extension Office by **July 8**.
- b. An Absentee Exhibitor Form must be attached to each exhibit. Answer all questions thoroughly in your own words. Answers may be printed or typed. Please be sure all signatures are filled in on each form.
- c. Absentee Excuse Forms and Absentee Exhibitor Forms are available from the Warren County Extension Office in Monmouth, and it is the responsibility of each exhibitor to procure these forms in a timely manner.

It is the responsibility of each exhibitor to procure these forms and the required signatures by the deadlines.
