COVID Guidance for the 4-H New Year

The 4-H New Year is almost here and we are so excited to introduce new tools, new projects, and launch into the next great 4-H year!

Also, please be looking for a special delivery in your mailbox with a small token to celebrate our 4-H community. We were excited to see so many of you at State Fair this year, and we know that 4-H youth are excited to see each other again. We are, too!

This year, we'll have a continued focus on keeping our youth, families, and volunteers safe during 4-H experiences. As such, anyone attending a 4-H indoor meeting or event **must wear face coverings** (that cover the nose and mouth) regardless of vaccination status, except for when eating and drinking. At outdoor meetings and events, face coverings will be encouraged, and attendees must wear face coverings when social distancing is not possible.

In addition, social distancing of at least 6 feet between attendees from different households must be followed. Additional cleaning and sanitizing procedures will also be in place. If anyone attending has a medical exception to face coverings, we encourage you to reach out to your local Extension staff for help in providing an accommodation. As always, we will continue to monitor and follow IDPH, CDC, and University guidelines and will keep you updated of any changes.

We continue to be humbled by the care you have taken to keep each other safe. Thank you for all you have done and continue to do and we are looking forward to a great year!

RULES & REQUIREMENTS:

- 1. Entry fees per exhibitor: \$3.00 per class OR \$10.00 all day. NO REFUND after entries are made.
- 2. Exhibitor is limited to one (1) entry per class.
- 3. Exhibitor must provide the following at registration: a) horse ownership/lease papers 4-H members, these are the same papers as were turned in to your local Extension office, b) Agreement to Assume Risk & Release from Liability form, c) Negative Coggins (Electronic or Paper Copy).
- 4. Exhibitor must be currently enrolled in 4-H or be an active high school FFA member. Age for all classes is determined as of January 1. Members enrolled in 2020-2021 or 2021-2022 4H year are eligible to show.
- 5. No stallions allowed.
- 6. All ponies must measure at 8:45 a.m. and be 56" & under.
- 7. A horse may be exhibited by only one (1) 4-H member (horses may not be shared).
- 8. Proper Western or English attire is required. No t-shirts, tennis shoes, or ball caps.
- 9. Helmets with a safety harness (FASTENED & BUCKLED) are required when mounted inside and outside the arena, including during the Costume Class. Helmets must meet ASTM/SEI standards.
- 10. A horse can be entered in one halter class: class 1, 2, 3, or 4.
- 11. All riding classes will be with a closed gate.
- 12. Up to six placings in each class. Judge's decision is final.
- 13. No alcoholic beverages.
- 14. ADULTS ARE NOT TO RIDE ON THE GROUNDS. Adults may lunge for youth.
- 15. Door prizes will be awarded during the show. Must be present to win.
- 16. Neither the show nor the sponsors will be responsible for any accidents to the persons or the property of an exhibitor.
- 17. 5-minute tack change will be allowed between classes where needed. Riders who do not have tack changes should be at gate by end of the preceding class.



Unit-Wide Policies

It is important for you to either review the Unit-Wide policies or become familiar with them. Since we are beginning the new 4-H year, we want everyone to have a copy of the unit-wide policies for 4-H. We are trying to keep the deadlines consistent so, it is easier for everyone to remember the dates. If a **deadline** lands on a weekend the paperwork needs to be turned into the drop box on Monday prior to 7:59 a.m.

- October 15th New members must turn in the Lifetime Risk Form and emergency medical form into the
 office or to your 4-H leader. Returning members, please turn your emergency medical form in to your
 leader.
- **December 1**st- Re-enrollment deadline. The step by step guide will be emailed to you once 4-H Online opens for re-enrollment. **If you were a member last year, and you miss the December 1, 2021 re-enrollment deadline, you will not be eligible to participate in the 2022 4-H shows at the fair.**
- The \$20 program fee is required. We will invoice your 4-H clubs; work with them on your 4-H Club's payment arrangement.
- Members will need to attend at least four meetings a year to be eligible to participate in your county's 4-H fair. You have to be physically present at the 4-H meeting or logged in and attending via a Zoom option. Excused absences do not count as attending.
- At minimum members must complete a talk or demonstration. However, clubs may require both.
- Secretaries are required to send attendance sheets monthly after their meeting to the Extension Office.
 This can be by email, scanned, mailed, or dropped off. We ask that you use the online Secretary book;
 you can either save it electronically or print it from your computer. We ask 4-H Leaders to review your
 secretary attendance sheet monthly prior to the office receiving them monthly.
- Treasurers need to make sure they are **balancing accounts monthly** and providing reports during each meeting. Also, make sure you are using the required online form. For the new 2021-2022 4-H year, Treasurers need to start with the ending balance of the prior 4-H year fiscal report.
- January 1 All Livestock Project enrollment deadline (Cat, Cattle, Chicken, Dog, Goat, Horse, Poultry, Rabbit, and Sheep). This is the last date you may add ANY livestock project and still be eligible to show that project at the county 4-H fair. Again, you may add this in 4-H online. We will know when you add past the January 1st date.
- March 1 General Project enrollment deadline. This is the last date you may add a general project and still be eligible to show that project at the county 4-H fair. Remember that you already turned in your project enrollment when you re-enrolled in 4-H Online. However, if you need to add a general show project you may do so before this deadline. This is where you tell us what projects you want to learn more about!
- May 1- Horse project member's ownership/lease paperwork and pictures papers due to the office.
- May 1 Youth for the Quality Care of Animals (YQCA) yearly certification is required of all livestock project members exhibiting cattle, sheep, swine, and goats. For cats, dogs, rabbits, poultry and horses, QAEC will still be required. If you plan to show livestock at the county and/or state fair, this is now a state requirement. Ask your local extension office about ways to complete this training online or in person.
- 4 Weeks Before Fair -Entries are due online by 11:59 p.m in FairEntry https://fairentry.com/. Please keep in mind that staff cannot help you after hours that day. It is suggested that you have the entries completed online prior to office closing at 4:00 p.m. that day. Just because you enroll in a project doesn't mean you are automatically entered in the fair. Late entries will not be accepted. Please make sure you complete your online entries. This is where you tell us what projects you plan to bring to the fair. Watch the newsletter and the 4-H Facebook page for dates where you can stop in and get help with entries.

This map is intended to give you an overview of the workshops that will be offered in the 2021-2022 4-H year in our Unit so that you can plan ahead. If you are interested in learning about a new project, this is your opportunity! We hope that you utilize this opportunity to learn and grow in your 4-H journey.



Join the Fun

Have you been thinking about asking family and friends to join your 4-H club? Have you been thinking about switching 4-H clubs to better fit your schedule? **NOW** is the perfect time to change! If you are already a member and would like to switch clubs, give Jill a call and she can work with you to make it a smooth transaction. To help you invite family and friends to join your 4-H club we offer you some answers to the most frequent questions we get at the office.

What is 4-H?

4-H is a voluntary, informal education program for young people ages 8-18, as of September 1st of the current 4-H year. 4-H Cloverbuds is a program for younger children who are 5-7 years old.

Isn't 4-H just for farm kids?

No! 4-H is for all young people, regardless of where they live, what their backgrounds are, or what interests them. Today in Illinois most 4-H members are from urban areas and they participate in projects to learn many different life skills.

Who conducts 4-H?

The Illinois 4-H program is conducted by University of Illinois Extension at the University of Illinois at Urbana-Champaign. County and state programs are directed by Extension staff who train and support volunteers who work with 4-H members. An Extension Council comprised of local residents serves in an advisory capacity to the Extension staff to coordinate, organize, and plan programming in the unit.

Want to continue your 4-H journey?

Sign a College Contract with us! If you are not yet 19 by September 1, 2021, then you are eligible to continue your Warren or Henderson County 4-H membership with us. Ask Jill for more information!

Federation bands together the local 4-H clubs into a central representative body for the improvement of the 4-H club program.
