Monday, August 12.

- Remove all the tags and ribbons from our local show and attach the state fair tag to the exhibit.
- 4-H members should plan to arrive in Springfield at the fairgrounds between 8 and 9:30 a.m. Traffic can be very busy, so give yourself plenty of time.
- Once on the fairgrounds, make your way to the far west side of the fairgrounds.... At the Orr Building.
- 4-H members will drop their projects off at the table for their project area between 8 and 9:30 a.m. Then, check the master schedule to see what time YOUR conference judging begins. Everyone will have at least a 10-minute judging time to discuss your project with a judge. Return to your judging area about 10 minutes before your scheduled time. Your project will remain on display until 3:30 that day. Be sure to come back and pick it up before 4:30 closing time.
- No projects may be removed from the judging area until 3:30 p.m. It's the rule, so follow it! If you need to leave early, please arrange with someone else from your county to pick up your project. Be sure to give them your claim ticket.
- There will be lots of other fun things to do in the Orr Building.

Fair Passes

The Boone County Fair will be using a punchstyle pass for 4-H'ers, exhibitors and season pass holders to enter the fair gates. Each day, your pass will be punched when entering the gate. Once your pass is punched for that day, you will not be allowed to enter using that pass again. Therefore, if you need to leave during the day and want to return later, you will need to receive a hand stamp at the gate upon exiting. There will be a different stamp each day.

Do Not laminate your Fair Pass. If you need to protect it, put it in a snack size baggie. Laminated passes will be confiscated. **Please have your pass ready when entering so that, we don't cause a backup at the gate.** Also, upon returning please be ready to show your hand stamp because the gate personnel will need to use a special light to read your stamp.

Fair Parking Stickers

Exhibitors with a 4-H parking sticker may drive their vehicle on to the fairgrounds for the purpose of delivering supplies until 10:00 a.m. on Wednesday through Sunday of



the Fair. Vehicles may enter through Gates 3 or 4 (after 10:00 a.m. you must exit using gate 4). After 10:00 a.m., all vehicles must be parked outside the fair gates. *(Exception – Wednesday 4-H horse show exhibitors may park by the pony arena.)* After 10:00 a.m., only vehicles with camping or official stickers will be allowed to enter through gate 4. On the outside of gate 3, there will be a designated area for handicap and exhibitor parking.

Fair Shows & Auctions Dress Code

AF

In order to promote a professional appearance by 4-H members, ALL 4-H members are to follow the dress code while in the show ring and sale ring. Deviations from the dress code will result in a request to change before you show or sell your animal. This dress code is not subject to personal interpretation and will be strictly adhered to. Please refer to the 4-H Show Book, page 45, for the complete dress code.

Our office received several complaints about improper dress from some of our 4-H exhibitors during past fairs. Please remember that you need to dress appropriately during all aspects of the 4-H events (weigh in, show ring and sale ring). Good rule of thumb if you aren't allowed to wear it to school (short-shorts, spaghetti straps, etc.) then you should not wear it during a 4-H event. Parents please help your child/young adult make the appropriate clothing decision. Thank you for your cooperation.

"The Department of Agriculture shall use its best efforts to secure sufficient appropriations to fund premiums. In the past, the Illinois Department of Ag has provided funds to local Illinois 4-H members in the forms of premiums (cash prizes) for participation in 4-H shows and exhibitions. We currently have no guarantee that funds for the 2019 shows will be provided. We treasure each of our 4-H families and know that you make a financial investment in your 4-H project work. We hope you continue to take pride in your 4-H learning and continue to participate fully in the 4-H program.

Understanding IRS regulations — Program Participants (including minors) will be required to provide their social security number or foreign national tax ID number prior to receiving a prize, gift or award to ensure proper IRS reporting as required by law. This sensitive information is kept confidential and handled through security protected software (PEAR). Participants will not be eligible for prize, gift or award if social security or foreign national tax ID information is not provided. When we receive more information, we will share what we know. <u>This is not a 4-H or</u> <u>University of Illinois directive; this is a requirement of the Internal Revenue Service.</u>

Health Regulations

A copy of the state health regulations is included in the 2019 4-H Show Book and we will adhere to these. Health or vaccination papers for your specific project must be available upon request by the health inspector in charge of your division. If the health rules for your project have not been followed as stated in the State Health rules, your project will be sent home. This is for the safety of your project and the projects of fellow 4-H'ers.



Some requirements will require testing that may take several days to complete. Don't wait too long to have your health paper requirements taken care of. Be sure to show your veterinarian what is specifically required.

Sheep Reminder - When getting your health certificates done; each animal must be listed. **All sheep must be in the sheep barn on Tuesday, August 6 by 7:00 p.m.** *Before unloading sheep, find Bob Walberg, 4-H sheep superintendent, to check papers and animals. Bob will be there from 1:00 p.m. – 7:00 p.m. on Tuesday. If you are bringing sheep prior to this time, please notify Bob at 815-544-2100 or 815-670-1170.*

Swine Reminder – *All swine must have a Health Paper/Certificate of Veterinary Inspection (CVI).* Each pig should be identified on the Health Paper/CVI using its ear notch.

Swine Barn Check-in

All Swine must be in place in the swine barn

by 12:00 p.m. on Tuesday, August 6. Please have an adult or a leader from your club be present for check in. That person is responsible for gathering all club members CVI's and purebred papers. This will help to speed up the check in process. Also, all Swine exhibitors need a premise ID.

Trucking Designation Form

This form **MUST** be turned into the designated drop-off location in the swine barn by 8:30 a.m. on Thursday, August 8. Turn in early as facilities will be assigned on a first-come, first-serve basis.

MASTER SHOWMANSHIP COMPETITION

Friday, August 9, 5:00 P.M. + Livestock Show Arena

This year, we will be hosting the second Master Showmanship Competition for Boone County 4-H members. To qualify, you must be the first place winner in the *Senior Showmanship* classes from the following species: *Beef, Dairy Cattle, Dairy Goats, Dairy Steers, Sheep and Swine.* For the general rules, please see page 53 of the 2019 Boone County 4-H Show Book.

This opportunity will give the participant a chance to broaden their knowledge about other species and showcase their showmanship abilities in the 5 species (dairy steers will not be included in the animal line).

FAIR CLEAN-UP

The fair will soon be over and then comes the hard labor - clean up! All 4-H'ers and parents are asked to come and help with the clean up. Clean-up is a big job; if everyone helps, it goes so much faster. 4-H'ers are responsible for cleaning the whole barn (including open show pens) this is in exchange for no pen rent.

Clean Up Schedule

Rabbits – TBD; an email will be sent to members when details are available.

Sunday, August 11 - 4:30 p.m.

Sheep - clean away from center and outside fence and take down all steel gates

Sunday, August 11 - 6:00 p.m.

Swine - clean all pens and put in manure bunker (including open show)

Goat - clean all pens to center aisle & assist with putting gates on the wagon

Monday, August 12 - 1:00 p.m.

Dairy - rake away from center to outside fence

Monday, August 12 - 4:30 p.m. (or as soon as you can make it)

Horse - clean draft horse pens to center aisle

Monday, August 12 - 5:00 p.m.

Beef - rake away from center to outside fence.

Please bring pitchforks, rakes and shovels. We encourage all 4-H'ers (large livestock, dogs, cats, rabbits, and non-livestock exhibitors) to help with clean up.

2019 Auction Information

Please refer to the 2019 Boone County 4-H Show Book for the complete information on the Fair Auctions. (pages 45-47). This Auction is sponsored by the Boone County Auction Association NFP, INC.

The 2019 Livestock Auction will start at 5:00 p.m., Thursday, Aug. 8 in the Livestock Show Arena. Order of selling- Swine, Beef, Lambs, Goats, and Dairy Champions*,

Dairy Steers, with champions first in each department. * Dairy products will be sold by the Champion Best of Show and the Junior Champion Best of Show. The Fur & Feather auction will be held on Saturday, August 10 at 3:00 p.m. in the Livestock Show Arena. The sale order will be Rabbits then Poultry.

All animals will be weighed <u>only once</u> at the times stated in each department. <u>No reweighs.</u> Only altered males such as steers, barrows, dairy steer and wethers can be sold in the auction.

Auction Policy: No announcements of donating to a charity or retaining show rights/ownership will be allowed in the auction ring before, during or after an animal is sold.

All 4-H'ers must verify that their auction animal has met the Quality Assurance Requirements regarding drug withdrawal and eligibility for slaughter in order to sell in the auction. *This statement must be turned in when weighing your animal(s).* Forms can be obtained online at http://web.extension.illinois.edu/bdo or at the Extension Office. *Animals sold in the Livestock Auction must have been shown during the Boone County 4-H Show.*

<u>Weight Requirements</u>: (check the 2019 4 -H Show Book for all additional weigh-in times and requirements). **Steers** - Must weigh at least **1,000 lbs.** and be <u>finished</u>.

Dairy Steers - Must weigh at least 1,050 lbs. and must be of "quality grade good" in the judge's opinion.
Sheep (Individual Fat Lamb--Wethers Only)- Animals must weigh at least 80 lbs., unless champion or reserve.
Swine (Barrows Only) - Barrows must weigh between 230 and 290 lbs. to sell in the auction.

Goat (Wethers Only) – Wethers must weigh at least 75 lbs.

- **Rabbits** All rabbits must weigh a minimum of **6 lbs**. with the exception of the meat pen, which must weigh between 3 1/2 and 5 1/2 lbs. each.
- Poultry All birds must be Young Males or Young Females (6 months and under). Birds must be in good health and must have received a BLUE ribbon during the 4-H Poultry show. Weight Requirements: Meat Pens 5 lbs each, Ducks 4 lbs, Layer Pens must be pullets, Pair of call Ducks, Geese (young) 8lbs, Turkeys (young) 20 lbs, Novelty birds including bantams. Note: All poultry selling will receive a metal leg band applied by the 4-H superintendent.

General Auction Notes:

- If a 4-H member shows in more than one division such as steers and swine, he or she must decide in which division to sell. The 4-H member can only sell in one division.
- Each 4-H member selling in the auction will be charged an auction commission rate of 5%. The auction commission goes to the Auction Association which uses the funds to make improvements of various livestock facilities at the fairgrounds as well as supporting 4-H educational opportunities.
- The buyer will pay trucking fees of animals bought in the auction.
- For the Fur and Feather Auction 4-H'ers will be permitted to sell two lots in the auction. (ie. One rabbit lot and one bird lot OR two rabbit lots OR two birds lots.
- 4-H members should show courtesy toward their buyer. Be sure to thank your buyer. If you are courteous, we can have a successful sale every year for many years. 4-H members must feed and care for their animals until 4:00 p.m. on Sunday. Auctioned animals are released to the buyer at this time (Exception: Swine is a terminal show).

- A parent or friend can record you—you're not being evaluated on the video but on your 4-H story. Of course, the more creative the video content, the better your chance of winning.

- Videos will be accepted through August 1. Winners will be announced and shown at the Illinois State Fair.
