- ⇒ Attend at least <u>four</u> 4-H meetings prior to a 4-H project show.

# Show-A-Rama

- All youth enrolled in general 4-H projects should plan to show at the 4-H Show-A-Rama on Thursday,
   August 1 at the Ag Building in Scheve Park in Mascoutah.
- Clothing, foods and nutrition, cake decorating, and computer science projects will be shown on July 13th at the 4-H Show at Turkey Hill Grange. Livestock will be exhibited at the 4-H Livestock shows at the Ag Building August 2-4. Those enrolled in a livestock projects that cannot show a live animal may exhibit in the "Animal Science" class at the Show-A-Rama.
- Show-A-Rama is also an opportunity for those enrolled in SPIN Clubs (i.e. Robotics & Shooting Sports, etc.) to exhibit a project on what they have learned throughout the year.
- Show-A-Rama Registration will take place the day of the show from 5:00-6:00pm.
- Judging at Show-A-Rama will begin at 6:00pm and go until approximately 8:30pm. If you are unable to attend, your project can be dropped off at the Extension office the week prior to the show.
- No parents are leaders will be allowed in the judging area while judging is going on.
- Ribbons will be placed on the projects on the night of August 1 after all judging is completed and will be able to be viewed the next day when the Ag Building opens.



### Shooting Sports volunteer training on target for July 20-21

Help ensure young people are exposed to everything the outdoors and shooting sports has to offer by becoming a certified 4-H volunteer. Volunteers should apply at their local Extension office. Volunteers must also complete a weekend training July 20-21 at 4-H Memorial Camp in Monticello. Volunteers must be at least 21 years of age. Cost is \$95. The deadline is early July, but counties must complete screenings prior to registering volunteers, so don't delay.

### Have you heard of the Youth for the Quality Care of Animals (YQCA) training?

- If you have, you're probably wondering 1) what it is and 2) if it is required to exhibit your livestock or animal science posters at the county shows.
  - $\rightarrow$  1) Youth for the Quality Care of Animals (YQCA) is a national multi-species quality assurance program for youth ages 8 to 21 with a focus on three core pillars: food safety, animal well-being, and character development.
  - $\rightarrow$  2) For this 4-H year, the YQCA training is <u>NOT</u> required for youth to exhibit their livestock or animal science posters at the 2019 St. Clair County 4-H Show-a-Rama or 4-H livestock shows.

### **Great Neighbor contest due June 16**

### **4-H STORYTELLERS**

### Be authentic | Share truth | Build connections

In **July**, 4-H members will be invited to become a 4-H Storyteller. In the fall, 20 youth selected from the applicants will be trained by some of Illinois's finest storytellers. The stories may take the form of written word: blogs, poetry, letters. They may take the form of art: photography, art, comics. They may take the form of sound: video, song, podcast. 4-H Storytellers will tell their personal stories, and in doing so, we will see 4-H in action in their lives. Look for more in the July newsletter. This opportunity is open to youth who will be in grades 8 to 11 this fall.

Applicants will be asked to submit two original examples of any of the following things: blogs, poetry, letters, photography, art, comics, video, song, podcast, or other form not listed. The two examples may be of the same form or different forms. Applicants must also answer the following question using whatever medium they want: **What story do you have to tell and why is that topic important to be shared?** The program is sponsored in full by the Illinois 4-H Foundation.

### Which dairy cow do you place first?

Line 'em up and rank them at the 2019 Illinois 4-H State Dairy Cattle Judging Contest. Registration begins at 9 a.m. **Aug. 17** at the Illinois State Fairgrounds, and the contest <u>begins at 10</u>. All contestants must be current 4-H members, but you do not need to be enrolled in a dairy project. There will be six classes of cows and heifers of various breeds. Youth 13 and younger (as of 1/1/19) will be in the junior division. Youth 14 and older will be in the senior division.



All participants will be invited to present oral reasons, but it is not mandatory. Juniors may read or recite from memory. Those seniors wishing to be considered for the state team must give two sets of oral reasons. State team members must be at least 14 but not older than 18 as of Jan. 1, 2019. The national contest will be Sept. 30 in Madison, Wisconsin. The national team is supported with funds from the Illinois 4-H Foundation.

### New awards, new scoresheets at Illinois State Fair

4-H members selected at their county to exhibit at the state fair will see some changes in the way exhibits are judged and prizes awarded. Judges at the state fair will use a 10-point scale and give members a score for each element of their exhibit:

Their knowledge about the project, Their conference presentation of the project, The presentation of the exhibit The new scoresheets are all posted online @ go.illinois.edu/4Hstatefair. For each EXHIBIT CLASS, a champion and reserve champion will be awarded based on points received.

In addition, **INSPIRE AWARDS** will be given at the judges' discretion for work they wish to highlight or acknowledge. Awards will vary in quantity, description, and type between project areas. These awards will not be based solely on scores. Check back soon for more on the new judging and award systems.

### **Poultry Testing CANCELLED**

Please see the official notification from the Illinois Department of Agriculture:

"Due to the shortage of antigen necessary to conduct Pullorum-Typhoid testing, the State of Illinois is waiving the pullorum requirements for exhibition. Once antigen becomes available, this waiver will be rescinded and all flocks participating in the National Poultry Improvement Plan will be required to conduct their annual test. Reciprocity with other states is not guaranteed and producers/exhibitors are responsible for contacting those state officials regarding compliance with entry requirements."

### End of year award time is approaching

Whether you are a first-year 4-H member or a longtime member, it's time to focus on pulling together information for your 4-H award applications. Even younger members can submit the 4-H Experience Application and be eligible for 4-H recognition. Older members can submit both the 4-H Experience Application and the Illinois 4-H Award Application to be eligible for state recognition, scholarships, and/or trips.



The **Illinois 4-H Experience Award Application** focuses on all of those events and activities that you have experienced during the 4-H year in four areas: *Participation, Community Service, Leadership,* and *Project Learning*. ### Save the date for fall shooting sports contests

Test your skill at the State Shooting Sports contests this fall. Read the age restrictions carefully. You may participate in one, two, three, or all four contests as long as you've received instruction from a certified 4-H instructor in THAT discipline. The top performers this fall may be eligible to compete in the 2020 National 4-H Shooting Sports Contest. Registrations for all State Shoots begins July 15

### Age Requirements for the State Shoots:

- Participants must be enrolled members of an active 4-H Shooting Sports Club for the 2019-20 year, so it is important youth re-enroll as soon as the new year begins in September.
- Youth may only compete in the discipline for which they have received instruction from a certified 4-H volunteer instructor. For example, youth who are members of a shotgun club led by a state-certified shotgun instructor cannot register for the pistol contest unless they have also participated in supervised instruction from a state-certified 4-H pistol instructor.
- Minimum Age: Youth must be at least 14 years of age by Jan. 1, 2020 to compete.
- Maximum Age: Youth must be no older than 18 on Sept. 1, 2019 to participate.

To be selected for the national competition team, youth must not turn 19 before Jan. 1, 2020. Thus, youth in their final year of 4-H who turn 19 in September, October, November, or December 2019 may participate in the state contest but cannot be selected for the national contest.

#### Shoot dates:

Shotgun will be held September 14 at the Brittany Shooting Park, Bunker Hill

Archery will be held September 21 at the Pekin Archers in Pekin.

Rifle & Pistol will be held September Oct. 12 -13 at the Central Illinois Precision Shooting (CIPS), Bloomington
