#### **Guest Presentation:**

Mark Jeffrey and Mark Marchard with the Regional Office of Education Atkinson Alternatives were guest speakers at the October 19, 2021 meeting. They shared information about the The ExCEL Alternative Academy that included the following:

- Stop for a second and think about the worst thing you ever did between the ages of 14-18. Now pretend the lights are turned on and everyone can see you. There goes your future. Everyone has a WHY.
- **Stop** following traditions; using practices that do not work for students; listening to your fears; refusing to pivot; letting kids be smarter than us; living in your comfort zone.
- **Collab Fab** Collaborate with local agencies; local businesses; local schools and ed tech; local educators and boomers; anyone who will listen and put up with you!
- **Listen, Linda!** Listen with more than your ears; how your students are G.O.O.D.; to where your students are; to what is real, relevant, and relatable to your students; listen to your gut!
- CHART-6 categories, open book document to chart kids' behavior. 6 levels to earn incentives.
- WWRP, Fast Track for freshman and sophomores; Step Program; Behind the Wheel; gamification of some classes; atomic habits; daily small wins; SMART goals; assess; Project based learning=Modeled Lifelong Learning.
- We must go beyond impossible pedagogy-to mission impossible pedagogy-to visioneering our students unbridled success. Their gifts will make room for them.

### Fiscal Report:

- Kyle McEwen offered information on Mercer Better Together's *Get Wired* program that is supported by Russell Medley, Extension community and economic development educator. They are recruiting for the fellowship program position, which is a 21-month commitment focusing on broadband.
- Dawn Temple reported on the bioreactor installation field day that featured presentations by Reid Christiansen, and Brian Maxwell, University of Illinois Department of Crop Sciences faculty, along with Rachel Curry, Extension Watershed Quality Outreach Associate, presented.
   Additionally, a local workgroup is meeting with Henry, Mercer and Rock Island Counties.
- Bob Mueller added a committee was begun working to stop the outflow of people from Stark County. Several banks and entities are providing video and opportunities for the group, and a school-work option are also in the works.
