IMPORTANT INFORMATION FOR LIVESTOCK EXHIBITORS!

This year, Dr. Denise Roberts will be present at the livestock weigh-in in the livestock arena on Monday morning of the fair, July 15.

If you have a <u>market</u> animal, you will need to bring its Certificate of Veterinary Inspection (CVI) with you for her to look at when you bring the animal to the arena to be weighed.

If you have a *breeding* animal, you will need to bring a CVI and registration papers if the animal is registered.

An Important Reminder to Livestock Exhibitors:

The Junior Fair Board would like to remind all youth planning to participate in the auction at the fair that animals presented for sale in the auction must be turned over to the buyer at the buyer's discretion. It is solely the buyer's prerogative to either take possession of the animal or donate it back to the exhibitor.

Failure to turn an animal over to a buyer who wishes to take possession of the animal could result in a loss of ALL auction proceeds for the exhibitor and could possibly result in other sanctions as seen fit by the fair board.

So, in summary, <u>if you plan to sell an animal in the auction</u>, <u>please understand that the buyer has</u> <u>every right to take the animal</u>. As a general recommendation, if you wish to retain possession of your animal, it should not be placed in the livestock auction.

4-H Show Policies

Please read your 4-H Exhibit Requirements handbook.

Rules regarding exhibiting of projects can be found in your handbook. The handbook is your guide to the fair and contains essential information. You need to familiarize yourself with it before coming to the 4-H shows. A very important rule that we want to bring to your attention is below. Please see your handbook for other rules and information.

A very important rule regarding eligibility*:

A youth that enrolls in a 4-H club/group <u>must</u> attend two-thirds (2/3) of meetings, tours, workshop or other activities sponsored by the club/group before July 1, current 4-H year, in order to be considered as a 4-H member. A community club/group must have at least 6 meetings before July 1. In order for youth to take part in any 4-H exhibitions (which includes the Illinois State Fair – Livestock and General Projects), receive 4-H premiums, or other 4-H awards and recognitions, he or she must meet the requirements of this attendance policy. The 4-H Club Leader will verify the meeting attendance of each 4-H member to the Extension staff by July 1.

*This does not pertain to Wabash County Junior Fair shows.

Can't Show Your General Project? (This does not apply to Livestock, Dogs, and Cats!)

If a 4-H member is unable to attend a general project show, he or she may seek approval for judging a static project(s). The exhibitor must indicate as such on the entry form or contact the Extension office and submit the following to the Extension office no later than Wednesday, July 10:

- 1. An Excused Absence Form (obtain from the Extension Office)
- 2. Your completed project record sheet
- 3. A brief written report telling about the project (what you did) and why you are unable to show it in-person
- 4. Your project

Please note the following:

- Exhibitors who are absent from the judging will not be eligible to advance to the State Fair.
- An excused absence from the county show refers to such conflicts as 4-H events, school-related events, family emergencies, work, etc.

Soil & Water Conservation Awards

Any youth interested in trying for these awards do not have to be enrolled in the Natural Resources project area

4-H 804 Soil and Water Conservation District Display Award - Wabash County 4-H and Jr. Fair, Display can be of any type so long as it shows a conservation practice. Things done in the past have been table models of conservation practice, usually made of styrofoam, cardboard, wood, etc. and labelled to what practice they are.

- 1. The regulations of the 4-H and Jr. Fair shall be adhered to and judging will be done by the Wabash County SWCD Board.
- 2. The winner will be awarded a certificate and prize at the Wabash County Fair with a plaque awarded at the SWCD Annual Meeting.
- 3. The Wabash County Soil and Water Conservation District would like to have the opportunity to display it at their Annual Meeting and office. If you have any questions about conservation practices, need examples, want to know basic construction of the conservation practices, or anything about this contest, call the Wabash County Soil and Water Conservation District at 618-262-5430.

The 4-H Conservation Photograph Display Contest - Photos may be either color or

black and white. The theme of the photos must be conservation related. Entries may

be either of single photos with one photo on a page with caption below in an binder or with

a larger photo on one page and the page following with the caption encased in a binder or a

poster board sheet no larger than 18" by 24" with photos attached and captions below.

This display cannot have been judged in the 4-H photography projects.

Monetary prize of \$10.00 and certificate will be given to first place and a matching

monetary prize of \$10.00 to the member's 4-H Club. The Wabash County Soil and

Water Conservation District would like the entry to display in the year following at

their office and Annual Meeting. If you have any questions about conservation practices

The day for general projects chosen from Wabash County to be exhibited at the State Fair will be Saturday, August 10, 2019. If your project is selected by the judge at the county 4-H show to advance to the State Fair, and you decide to take your project, the State Fair entry forms will be due to the Extension office by 4:00pm on Thursday, July 18.

Junior fair exhibit books and entry forms can be obtained at the Extension office. Stall rent can also be paid and is due July 6. After this date, the fee will be doubled!

2019 Exhibition Livestock Health Requirements

Exhibitors are required to familiarize themselves with all the rules and regulations to exhibit livestock, dogs and cats at the 4-H shows.

Please refer to the yellow section of the 4-H exhibit handbook for the county fair and the light purple section for the State Fair.

For health requirements for cats and dogs, refer to page 21 (cats) and 33 (dogs) in the green section.

- Please ensure that all heath requirements and certifications are completed before your animal is brought to the fairgrounds. For questions regarding your animal's specific health requirements and regulations refer to the yellow pages in the 4-H Exhibit Requirement handbook or call your vet.

New awards, new scoresheets at Illinois State Fair

4-H members selected at their county to exhibit at the state fair will see some changes in the way exhibits are judged and prizes awarded. Judges at the state fair will use a 10-point scale and give members a score for each element of their exhibit:

Their knowledge about the project Their conference presentation of the project The presentation of the exhibit

The new scoresheets are all posted online @ go.illinois.edu/4Hstatefair. For each EXHIBIT CLASS, a champion and reserve champion will be awarded based on points received. Outstanding awards will also be awarded to any exhibit that achieves 80% or higher.
